

NURSERY GOODS AND SERVICE PURCHASE AGREEMENT

BUYER: _____ **DATE:** _____

This agreement, effective this date, made by and between Tawakoni Plant Farm Ltd. (hereinafter called "Seller"), 651 VZCR 3728, Wills Point, TX 75169, and Buyer.

Whereas, SELLER'S principal business operation is the production and sales of nursery plants.

Whereas, BUYER is desirous of purchasing certain nursery plants from SELLER, now therefore, SELLER and BUYER for mutual consideration heretofore agree as follows:

Plants: BUYER agrees to buy and SELLER agrees to sell the nursery plants at various times, places, and amount in the future as needed by BUYER.

Payment: BUYER agrees that in consideration for the nursery plants and services furnished by SELLER, BUYER shall pay the SELLER purchase price as invoiced and for each specific purchase of nursery plants and services, payment in accordance with the terms as specified in each particular invoice, including any shipping, freight or delivery charges to be paid as billed.

Ownership: BUYER agrees that until all payment as billed is paid in full, the nursery plants shall remain the property of SELLER and, at the option of the SELLER, shall be returned to SELLER in like condition as delivered, in the event that such payments are not made as provided in each invoice.

Applicable Laws: This agreement shall be governed in all respects by the laws of the State of Texas.

Courts: All suits, claims or causes of action arising out of or in any way concerning the rights or obligations of the parties hereto must be brought in any court of competent jurisdiction located in Van Zandt County, Texas; and the parties hereto agree that Van Zandt County

Notices: All notices required or permitted to be given shall be deemed given if in writing, deposited in a sealed envelope with postage thereon prepaid, certified mail, return receipt requested, addressed to BUYER at the address set forth as directed by BUYER at time of purchase of goods and services.
