- §1. The Town of Cohocton is authorized to compensate the Deputy Town Clerk, an appointed officer of the Town of Cohocton, for services rendered by said Deputy Town Clerk to the Town of Cohocton, at an hourly rate which shall be established, and may be amended from time to time, by resolution of the Town Board of the Town of Cohocton, New York.
- §2. This Local Law shall take effect immediately upon filing with the Secretary of State of the State of New York.
