About the Amana Sportsmen's Club:

In the winter of 1953, nine residents of Amana decided a sportsmen's club was needed. Their purpose was "To conserve and restore, the game, fish, and other wildlife and its habitat in the Amana Society and its environs; to seek to procure better fishing and hunting for sportsmen; to promote and maintain friendly relations with landowners and sportsmen; to cooperate in obtaining proper respect for, and observation of, the fish and game laws, and so far as possible to spread knowledge of useful wildlife among the residents of Amana." After several meetings during that winter and next spring, on May 20th, 1954 these men established the AMANA SPORTSMEN'S CLUB. There began the long tenure the club has enjoyed. In 2007 ASC became a non-profit (501(c)3) organization. Today, the club and its members still adhere to those words written long ago. In addition, hunter education, firearm safety, firearm shooting sports, and introduction of these to newcomers are now also a part of the club's purpose.
