ORDER

Considering the pretrial order executed by this Court in chambers on March 27, 2023, the issues raised before the Court on April 19, 2023, and this Court's desire to move this matter to conclusion;

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that the Motion for Expedited Scheduling Order and Trial filed by the Plaintiffs, be and hereby is GRANTED as follows:

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the Court vacates its March 27, 2023 order setting this matter for a first setting for trial beginning March 10, 2025.

IT IS FURTHER HEREBY ORDERED, ADJUDGED, AND DECREED that the first setting of this trial begin July 22, 2024. The Jury Bond shall be fixed in the amount to be determined at a pretrial conference consistent with the Louisiana Code of Civil Procedure and the local rules of the 19th Judicial District Court.

The Clerk of Court is hereby ordered to provide the trial judge with notice 50 days prior to the first day of trial that the required cash deposit (and/or bond) either has or has not been filed. Failure to post the cash deposit shall constitute a waiver of a trial by jury, and the trial will proceed as a bench trial. Jury management will be notified to remove the jury trial from its schedule in order to avoid the unnecessary expenditures associated with summoning jurors who are no longer required.

Jury charges and verdict forms shall be submitted directly to the court via regular mail and email at jyking@19thidc.org fourteen (14) days prior to the first setting of trial.

The number of days the Court has set aside for trial is 15 days.

Counsel for the Plaintiff shall notify the Court via email at jyking@19thidc.org 45 days in advance of the trial date to schedule a final pre-trial conference. Every attorney participating in the trial shall be present at the final pre-trial conference.
