CORRESPONDENCE FROM THE FISCAL OFFICER:

Minutes from the February Meeting being read prior by the Board were approved as read, so moved by Trustee Ellinger and seconded by Trustee Shaw. All were in favor with 2 ayes and no negative votes, motion passed. Trustee Ellinger motioned to move from temporary appropriations to permanent appropriations. Trustee Shaw seconded the motion. Roll call vote Ellinger – Yes, Shaw– Yes. Motion approved. Trustee Ellinger motioned to proceed with the Kingston loan for the purchase of a new EMS vehicle. Trustee Shaw seconded the motion. Roll call vote Ellinger – Yes, Shaw– Yes. Motion approved.

FIRE DEPARTMENT:

Captain Philipoulus reported monthly runs so far have been 12 fire and 33 EMS for a total of 182 runs YTD. Mutual aid was provided to Amanda, Berne, Clearcreek, Greenfield, and Lancaster. A total of 2 run to SCI. Squad pricing has been submitted and paperwork will be signed before the end of the month. Reminder that this is again non-burn time between 6am – 6pm.

OLD BUSINESS

- 1. The county engineer's office will keep Hocking Township informed as to the progress of the OPWC on Meister Road. Should be hearing something soon.
- 2. Hocking Township will continue to monitor Stonewall Cemetery Road and Stepath Mound Lane for erosion.
- 3. Due to the Army Corp of Engineers being short staffed, the trustees are asking Fairfield County to do a water study for the size of the culvert needed to cut down the erosion from Muddy Prairie Run Creek on Pleasant Valley Road. Trustee Ellinger spoke to Eric McCrady and they will get the recommended size.
- 4. Deputy Hummel and the Health Department will be checking on the property complaints on Hamburg Road. They will advise of the next steps.
- 5. James Mako has not heard of anything on the property at State Route 188 and Delmont Road. There are still rumors that there is a Loves fuel station going in at the property. Hocking Township has not been notified of anything officially.

NEW BUSINESS:

- 1. Hocking Township maintenance staff are clearing back brush and trimming limbs within the Hocking Township's right of way. Trustee Ellinger mentioned to be mindful when driving the roads for the safety of the staff and the driver.
- 2. Trustee Ellinger motioned to bid 400 tons of road salt for next winter for a budget of \$40,000. Trustee Shaw seconded the motion. Roll call vote Ellinger Yes, Shaw– Yes. Motion approved.

Trustee Ellinger moved to pay the warrants for the month seconded by Trustee Shaw. Roll call vote Ellinger – Yes, Shaw– Yes. Motion approved.

There being no further business to discuss Trustee Shaw motioned to adjourn and Trustee Ellinger seconded the motion.
