

RESERVATION FORM

Pleasant Twp. Park Shelter House

I (we), the undersigned, wish to reserve the Pleasant Twp. Park shelter house for the following date(s) and time:

_____. I (we) will abide by the following regulations.

Please read and initial the following items:

- _____ 1. Alcoholic beverages and tobacco products are STRICTLY PROHIBITED.
- _____ 2. Firearms of any kind are STRICTLY PROHIBITED. **Violators will be prosecuted.**
- _____ 3. Loud music or other disturbances are NOT permitted.
- _____ 4. Explosive Fireworks are STRICTLY PROHIBITED.
- _____ 5. The shelter house and grounds must be returned to the condition in which they are found at the start of the event.
- _____ 6. All trash must be placed in marked containers. ALL PLASTIC, GLASS AND METAL CANS AND BOTTLES ARE TO BE RECYCLED.
- _____ 7. All parties must vacate the park premises before SUNSET.
- _____ 8. An adult (age 21 or older) must be present at ALL times.
- _____ 9. **DOGS MUST BE ON A LEASH AT ALL TIMES.** Dog owners are to clean up after their pets.
- _____ 10. Vehicles are permitted only on the driveway and parking lot. A vehicle may be driven from the parking lot to the shelter house ONLY for unloading and loading, and then only when dry ground conditions permit.

The undersigned understands and hereby acknowledges that the Board of Trustees of Pleasant Township shall not be responsible for liable for personal injury or property damage occurring to persons and their guests and invitees while using the park shelter house for their own personal use, or for matters unrelated to the business of the Board of Trustees.

I (we) understand that this reservation is ONLY for the shelter house, one charcoal grill and the grassy area to the west to the shelter house (the remainder of the park is open for others to enjoy). I (we) agree to pay a **nonrefundable fee of \$50.00**, payable at the time of the reservation.

Failure to abide by one or more of the above rules and or damage to the shelter house or grounds will result in an **additional \$50.00 fee**, and forfeiture of any further use of the park shelter house.

The undersigned releases and discharges the Pleasant Township Board of Trustees from any liability, claims, or demands from injuries, damages, actions or causes of action that might arise from the use of the Township premises.
