Water Well Solutions also provided a quote on VFD for the transfer pump which is \$9,175.00 to acquire and install VFD. Fowler authorized Water Well Solutions to proceed on an emergency basis after speaking with Trustee Hammon and Trustee Dougherty, this ratifies the emergency purchase.
