	1.	I WILL CONDUCT MYSELF IN ACCORDANCE WITH THE FLORIDA FOOTBALL ALLIANCE CODE OF CONDUCT, RULES AND REGULATIONS.
	2.	I WILL RESPECT THE RULES OF THE GAME AND PLAY BY THEM.
	3.	I UNDERSTAND THAT I AM A PLAYER AND NOT A COACH AND WILL BEHAVE LIKE A PLAYER INCLUDING I WILL NOT SUBSTITUTE MYSELF INTO THE GAME WITHOUT COACHES CONSENT.
	4.	I WILL CONTROL MY TEMPER AND UNDERSTAND THAT VERBAL ABUSE OF AN OFFICIAL OR COACH WILL NOT BE TOLERATED AND IS GROUNDS FOR SUSPENSION.
	5.	I WILL NOT ARGUE WITH AN OFFICIAL. IF I DISAGREE WITH A DECISION I WILL INFORM THE COACHING STAFF AND NOT THE OFFICAL.
	6.	I UNDERSTAND THAT FIGHTING ON AND OFF THE FIELD, WEAPONS, AND THREATS ARE ZERO-TOLERANCE BY THE FFA AND SOUTHWEST FLORIDA GLADIATORS. SUSPENSION WILL BE ASSESSED FOR BOTH, NO EXCEPTIONS.
	7.	I WILL NOT THROW MY HELMENT/GEAR OR CURSE ON THE SIDELINE.
	8.	I WILL CONDUCT MYSELF AS A PROFESSIONAL WITH RESPECT FOR THE FIELD, FLAG, STAFF, COMPLEX OR FACILITY IN WHICH I PLAY. IF I FEEL IT NECESSARY TO PROTEST DURING THE NATIONAL ANTHEM I WILL DO SO BY REMAINING IN THE LOCKER ROOM WHILE IT IS PLAYED.
	9.	I WILL RESPECT THE RIGHTS, DIGNITY, AND WORTH OF THE FFA AND THE SOUTHWEST FLORIDA GLADIATORS ORGANIZATION, TEAMATES, COACHES AND FANS.
	10.	I WILL REFRAIN FROM ON-LINE CRITICISM OF TEAMMATES, COACHES, THE GLADIATOR ORGANIZATION, THE FFA, AND FANS. IF I HAVE AN ISSUE THAT NEEDS RESOLVED I WILL SPEAK TO THE GM, COACHES OR OWNERSHIP OF THE GLADIATORS FOR A RESOLUTION.
