Service Agreement

Tabby and Jack's requires proof of current rabies vaccine. Acceptable forms of proof are Veterinary records or verbal confirmation from the Veterinary Clinic. We do not accept tags as proof of rabies vaccine. Tabby and Jack's takes every precaution to protect each pet from harmful pathogens by sanitizing tubs, kennels, tables and tools between use. Although it is not required, we highly recommend that your pet be vaccinated against all infectious conditions, such as, Distemper, Parainfluenza, Bordetella and Parvovirus.

_____ PLEASE INITIAL

The safety and health of each pet is our primary concern. Although Tabby and Jack's uses natural products, we can not ensure that they are hypoallergenic due to each pet's individual sensitivities and therefore cannot be held responsible for allergic reactions or aggravation to pre-existing conditions. We also can not be held responsible for other pre-existing medical conditions (heart disease, respiratory disease, arthritis or clotting disorders) or aggravation of these conditions due to the grooming process.

_____ PLEASE INITIAL

If your pet is matted, it will be at Tabby and Jack's discretion on how best to handle the situation. Due to safety and risk of injury, we do not attempt the dematting procedure. It is also painful and unpleasant to the pet and therefore, shaving is the safest and most comfortable way to remove mats. Any matting will be discussed at check in. I understand there are not many options for preferred style on a matted dog or cat. I also understand that removing severe matts can cause sores and hematomas when removed. Therefore, I will not hold Tabby and Jack's responsible for any conditions caused by the matts.

_____ PLEASE INITIAL

Tabby and Jack's has the right to refuse/discontinue service to any pet due to health concerns, expired rabies vaccine or jeopardized safety of the pet/groomer.

_____ PLEASE INITIAL

If your pet becomes sick or injured while in our care, Tabby and Jack's will be designated as an agent and will do whatever is appropriate for his or her well-being. We will first attempt to contact you, but if contact can not be made it will be at our discretion to engage the services of a veterinarian at your expense.

_____ PLEASE INITIAL

I understand that all prices are approximate, and that the condition of my pet's coat and their disposition to being groomed may affect the time that it takes to complete the groom and therefore the cost. Grooming of pets with fleas will incur an automatic additional \$25.00 cleaning fee.

_____ PLEASE INITIAL

I understand that this agreement will remain in effect as long as I use Tabby and Jack's services.
