

2019 JUNIOR HUNTER PHEASANT HUNT

Dear Junior Hunter:

The Conservation Awareness Foundation, Inc., and the Federation of Dutchess County Fish & Game Clubs, Inc., in conjunction with the NYS Department of Environmental Conservation, are sponsoring a Junior Hunter Pheasant Hunt on Saturday, September 28, 2019, at the Lafayetteville Multiple Use Area on State Route 199 in the Town of Milan. The program, which is open to all Hudson Valley Junior Hunters (12 to 15-years of age), will consist of a brief pre-hunt session covering the following topics: understanding pheasant habitat, shooting skills, field safety, and Environmental Conservation Law. The briefing will be immediately followed by a field hunt.

RULES AND REGULATIONS FOR THE HUNT

1. This program is open only to Junior Hunters (**ages 12 to 15) who have passed a NYS Hunter Safety Course and are in possession of a valid NYS small Game License. **The child must be at least 12-years of age on the day of the hunt and/or still no older than 15- years of age on the day of the hunt.
2. Junior Hunters (ages 12 & 13) must be accompanied by a parent, legal guardian, or relative over 21. A relative must have written permission from parent or legal guardian.
3. Clothing of the participants should be appropriate for the type of weather, as the program will be held rain or shine. Junior Hunters and accompanying person afield must have at minimum **A BLAZE ORANGE OR BRIGHT PINK VEST AND HAT.**
4. Shooting glasses are **REQUIRED.**
5. The Junior Hunter must bring their own shotgun and shells. (Any shotgun legal for taking upland game in New York State may be used.)
6. The Junior Hunter is encouraged to bring a hunting dog. If you do not own a field dog, but one is available, would you like to be accompanied by one? Please indicate below.
7. Entries must be received by September 5, 2019. This program is on a first come-first served basis for an AM or PM hunt. The Junior Hunter will be notified by mail of the time they are to arrive at the Lafayetteville site.
