**Topic** Action

Question was asked about the higher fee for lawn mowing. We switched companies in 2019 to have all lawn mowing, maintenance, sprinklers, and weed control be conducted by Colonial Lawn & Garden because they offer higher quality mowing than the previously used company, and their rates were the most competitive compared to other options.

Dues remain at \$150 for 2020. Neighbors will be given the option to pay dues in two payments.

<u>FY2020 Budget</u>: The 2020 budget was proposed by the Board at the January Board of Directors Meeting and presented to the association. No discrepancies or questions among attendees.

<u>Block Watch/Emails:</u> Previously run by Jon Ison, he has expressed interest in stepping back and taking a break from being in charge of the block watch. <u>Snow Removal</u>: Josh Grenz with Grenz Family Landscaping is now conducting snow removal on the greenway sidewalks. <u>Calendar Dates:</u> The following dates were announced:

If you sell food, water, soda, etc., it is YOUR responsibility to also set out garbage cans for waste. Even if you do not sell these items, it is encouraged that you set out a garbage can to eliminate issues with litter.

Mona Purcell will place block sale ad in paper and place street signs.

Arborvitae: Continue to be an issue and a fire hazard. It is questionable if the drip system is even working, but no company will provide an estimate without first removing the debris and dead arbs in order to even access the drip line. Still considering the same options as presented previously: 1) remove all arbs and replace with fence, 2) remove all arbs and replace with new arbs, 3) remove dead/dying arbs and replace with new arbs, 4) continue maintaining arbs and just replace dead ones as finances allow. A new option is removal of the arbs entirely, leaving just the chain-link fence. Mona suggested the formation of a committee to assess options and costs. A motion was made and seconded. Jim Moon volunteered to chair the committee; other volunteer members include Sherri Moon, Jon Ison, Kelly Hescheles, Jim Klug, Linda Klug, and Mona Purcell. Copri will also assist with the committee since she had previously put work into assessing available options.
