

Nothing here prevents any party from using the word NIGERIA, NIGERIAN or any variation.
- b) Hosting any function, advertising, or engaging in any activity under the name Nigerians in Diaspora Organization (NIDO) Canada, Nigerians in Diaspora Organization (NIDO) of Canada, Nigerians in Diaspora, Nigerians in Diaspora Organization, NIDO CANADA, NIDO Canada, NIDO, or any confusingly similar name. Nothing here prevents any party from using the word NIGERIA, NIGERIAN or any variation
- c) Advertising, representing themselves as, or implying to any person, firm, government, corporation or the public at large that they are executives, directors, agents, members, employees or otherwise affiliated or associated with Nigerians in Diaspora Organization (NIDO) Canada, without written authorization from the Plaintiff; and

2. This action is hereby otherwise dismissed.
