#### **AMPS 2013 Show Theme**

During the November, 2012 meeting, we discussed and voted to approve a contest theme for our 2013 show.

The theme selected is:

"Hand Grenades and Atom Bombs:" Cold War armor along the Iron Curtain from the Arctic Circle to Turkey, 1950 to 1985, Warsaw Pact and NATO.

Eligibility will be based on subject nationality and markings and not country of origin. That is, the subjects must belong to one of the member states of NATO or the WARSAW Pact. Neutrals, even if the subject vehicle was manufactured by a NATO or WARSAW Pact member, are not eligible for the theme award.

This is a very broad theme, though, with a huge number of potential subjects. Hopefully we'll get a lot of participation. Also, this theme should complement the show theme selected by our IPMS friends.

## The "Naked Model" Special Category

We also approved a special category featuring ONLY built, but un-finished (i.e. not painted) models.

It is not our intent that models entered in this category should be constructed specifically for it, but rather that the category should offer an opportunity for modeler's to show-off their skills at basic and advanced construction during the course of a normal build. Therefore, in this special category, models may have areas filled or primed or have their interiors or other areas partially or completely finished at the modeler's discretion. However, any areas obscured by paint (either primed or finished, for example, as part of interior areas that will be inaccessible later in the build) WILL NOT BE JUDGED or SCORED. All visible, interior and/or exterior but up-painted, areas will be judged and scored.

Models should be presented to the judges in as complete a state as possible. However, separate parts or sub-assemblies may be displayed with the main part of the build on a single base. It is the modeler's responsibility to present the entire "naked model" package in a manner that can be moved by the runners from the registration area to the judging pits and then to the display tables. The runners WILL not relocate multiple separate parts or sub-assemblies which are not displayed on some sort of base with the main part of the build. The entirety of the "naked model" must fit on a single movement tray as provided at the registration area. Models that do not meet these criteria will be disqualified.

ALL "naked models" will be judged in the pits. NO "naked models" will be judged at the display tables (as for figures, vignettes, and dioramas).

We will modify the AMPS judging and scoring rules by taking all of the points in the Finishing and Weathering Scoring Group and moving them to the Construction Scoring Group. All of the other judging will be kept the same. The un-finished models will not be eligible for any of the other, regular "best of's" nor for the "Judge's Best in Show" awards.

However, we will present a special "naked model" award for the best model in this particular category, as well make regular G-S-B medal awards based on AMPS skill-levels and points break downs.

## Our June 2013 AMPS Show Figures, Vignettes and Dioramas Eligibility

Another special rule which will be in-effect at our June show is in regards to figures, vignettes, and diorama eligibility.

In order to simplify the entire show's organization for ourselves and our IPMS friends, we will modify the normal AMPS rules for eligibility for military figures and figure vignettes and dioramas. As all of you are aware, AMPS rules restrict military figures to those dating from 1899 and later. The intent of this rule is to associate military figures with the history of military AFVs. Normally, this is both logical and reasonable given AMP's charter.

However, for our show in June, presented in conjunction with the IPMS R-12 convention, adhering strictly to this rule would have required that both clubs offer historical figure categories with all of the required duplication of registration, registration fees, table space, and awards. Also, duplicate categories would mean that some figure modelers might have to register figures into both the IPMS and AMPS shows based on the 1899 AMPS cut-off.

So, to avoid all of these issues and hopefully make the show more welcoming to our participants, AMPS will open our figure, vignette and diorama categories to ALL military figure subjects regardless of era or historical periods (to include futuristic or sc-fi military figures). These will be judged according to normal AMPS rules and awards presented accordingly (to include "best of's" as applicable).

All other figures, civil, fantasy, super hero, robots, Gundam, sci-fi, etc, will be entered into the applicable IPMS categories to be judge according to their rules and procedures.

# "The Day Room"
