## **Bird Deterrent At The Pool**

Cimarron CIA installed a bird deterrent back in 2022 to help prevent the yellow crowned night herons from nesting in the trees surrounding the playground area and defecating on the playground units.

The bird deterrent installed at the pool is on a 24-hour system that uses distress and predator calls to humanely deter these birds. A reminder: The bird deterrent will be on only during nesting season (end of February through early August), then it will be turned off until the next year's nesting season. We apologize for any inconvenience this may cause to our residents.



As a reminder, yellow crowned night herons and other migratory birds are protected under federal law. It's illegal to shoot, trap, or harm them in any way.
