WHEREAS, the Board of Trustees wishes to establish standards for the operation and governance of the Association that serves as guiding principles for both the Board of Trustees and members of the Association: and,

WHEREAS, the Board has determined that it is in the best interests of the Association and the Association's members to adopt uniform procedures for dealing with resale and lender documentation requests;

NOW THEREFORE, BE IT RESOLVED, that the Board of Trustees, with the intent to initiate procedures for the purposes of covering the expenses for compiling, handling and copying the property records and fees associated with updating new owner information and or documentation requested for lender transactions, hereby adopts this *Resale and Lender Documentation Request Policy*.

- The Association may charge fees to cover administrative expenses with regard to documentation requested for the purposes of resale and/or lender transactions.
- 2. The Association may opt to charge a rush fee for orders requested to be received within an expedited time frame.
- 3. The Association may contract with an independent contractor for the purposes of streamlining the process and providing e-document and delivery services.
- 4. The Association may charge additional fees for recurring requests of the same documentation.
- 5. A fee schedule will be on the Association's website and available prior to order submission.
- 6. If any provision of this Policy is determined to be null and void, all other provisions of the Policy shall remain in full force and effect.
