

Crested Butte, CO 2023 Trip Information

Advanced Signup with \$200 Deposit Opens July 1

Dates: Feb 25- March 4, 2023

Lodging: 2-Bedroom/ 2-Bath condos at Plaza Condos – 100 feet from lifts.

Advanced signup with \$200 deposit: reserves your spot on the trip. Once airfare is **confirmed final**, you will have 10 days to cancel your trip reservation from the day the airfare is announced, or obtain your own airfare. *Advanced signup is only good until September. After that, the incremental payments are required by the payment dates listed in the schedule. The payment dates will be calculated when this sheet is updated and communicated to everyone.*

Airlines: Still to be confirmed. Final airfare cost will replace the current tentative amount of \$536 and be used to re-calculate the full trip price and this information sheet will be updated. It is probable that we will fly into Gunnison airport for a short ride (~40 miles) to the condos. The current tentative airline price is \$536 round trip.
