1. Call to order, declare meeting open to the public, and take roll.

President Patterson called the meeting to order at 2:01 PM. All Board members were present.

2. Public Comment.

No comments received.

3. Consider approval of Minutes of December 11, 2014 board meeting

Board Member Gattis motioned to approve the Minutes of the December 11, 2014 board meeting. The motion was seconded by Board Member Gibson and passed unanimously.

4. Review and approval of monthly invoices.

Mr. Satterwhite reviewed the monthly invoices.

Board Member Gattis motioned to approve the monthly invoices for a total of \$37,630.33. The motion was seconded by Board Member Newhouse and passed unanimously.

5. Receive Monthly Financial Information

Mr. Satterwhite reviewed the monthly financial information, as well as the end of year financials for 2014. Mrs. Atkins is working to invest the funds as directed by the Board at the previous meeting. Mr. Satterwhite also reviewed the aging report. Past due invoices are due for Lass Water Company, SSCGC Holdings, LLC and Silver Creek Oil & Gas. Late fees will be charged to these accounts. The other three accounts listed are not past due at this time.

6. Receive update on GMA 8 activities and development of Desired Future Conditions (DFCs)

At the last meeting, Mr. Satterwhite had reported that the model developed by INTERA was approved by the Texas Water Development Board (TWDB) and a proposal had been requested for them to complete additional model runs. The proposal was received in December, but four districts did not like the proposal and wanted to go out for proposals. After legal counsel review, the staff developed a Request for Qualifications, which was due in February. Four consultants submitted proposals. The next GMA 8 meeting is scheduled for March 25th for the participants to rank the consultants from 1 to 4 and then be able to vote on the consultants. The cost proposals will be provided after the ranking. Based on the action taken at the December meeting, Board Member Gattis has the authority to rank the consultants and the runs being proposed and vote for a consultant. The process has created a three-month delay in the process of establishing DFCs.

The Board unanimously agreed that Board Member Gattis has the authority to rank the consultants and vote for a consultant as well as make a decision on which runs the RRGCD would financially support.

Pursuant to Government Code 551.071, the Board of Directors adjourned into closed Executive Session at 2:20 PM to discuss the following:

Consultation with Attorney

The Board reconvened into Regular Session at 2:59 PM. President Patterson stated no action was taken on items discussed during the Executive Session.

At this time, President Patterson moved out of posted agenda order, beginning with Item 8.

8. Receive 2014 4th Quarter Report

Mr. Satterwhite presented the Quarterly report. The 2014 Annual Report will be presented at the April meeting. So far, 2015 has been a fairly wet year, with the local lakes up approximately 1 to 5 feet.

9. General Manager's Report

Mr. Satterwhite provided the current number of wells registered in the District. He explained that the current geodatabase well registration system has some deficiencies. The current system is not capable of providing the information that will be required for permitting decisions. The staff sees many areas for improvement in the current system and would like the opportunity to discuss with the board. He requested that the geodatabase committee, which consisted of Board Members Patterson, Latham and Mrs. Catterson to begin looking at other options to improve the system. The Board agreed unanimously to re-activate the committee.

At 3:04 PM, the Board took a brief break. The Board reconvened at 3:12 PM.

7. Consider and act upon compliance and enforcement activities for violations of District rules

Board Member Gattis motioned to issue one \$500 Major Violation on Preston Club Golf Course for failure to register one non-exempt well. The motion was seconded by Board Member Purcell and passed unanimously.

Board Member Purcell motioned to issue one \$500 Major Violation on Lass Water Company for failure to pay water use fees within 60 days of the date the fees were due. The motion was seconded by Board Member Gattis and passed unanimously with President Patterson abstaining.

Vice President Latham motioned to issue four (4) \$500 Major Violations on Pintail Farms for failure to register four (4) non-exempt wells for a total penalty of \$2000. The motion was seconded by Board Member Gibson. Board Member Purcell commented that the four first-time violations were in lieu of four (4) consecutive Major Violations. The motion passed unanimously with Board Member Newhouse abstaining.

Board Member Gattis motioned to notify violators of the penalty and provide 24 days until April 27 at 5:00 PM to come into full compliance or they will be required to attend a show cause hearing on May 21, 2015 at 2:00 PM. The motion was seconded by Secretary/Treasurer Wortham with President Patterson and Board Member Newhouse abstaining.

10. Open forum / discussion of new business for future meeting agendas

The next meeting was tentatively scheduled for May 21, 2015 at 2:00 PM.


The Texas Water Development Board website reflects Lake Bonham was at 99% of its conservation storage capacity in March 2015, and Lake Texoma at 90%.



CONSIDER AND ACT UPON CONTRACT WITH LBG GUYTON FOR SUPPORT AND TECHNICAL ASSISTANCE RELATED TO DESIRED FUTURE CONDITIONS;

ISSUE

Consider and act upon authorizing services of LBG Guyton Associates to assist the Red River Groundwater Conservation District ("District") with establishing the development of Defined Future Conditions (DFCs).

BACKGROUND

Each groundwater district in the State of Texas is expected to develop and adopt their DFCs by May 2016 in order to comply with mandates from the State of Texas. The DFCs for the District will be done in conjunction with other groundwater conservation districts in Groundwater Management Area 8 (GMA 8), which extends over the Trinity Aquifer from the Red River south to Burnet County. There are eleven groundwater districts in that geographic area.

CONSIDERATIONS

The District will have many decisions to make regarding model runs, rule development, and general GMA-8 topics over the course of the next few years. District staff believes LBG Guyton has provided valuable guidance thus far in the DFC process. The staff also believes that continued guidance from a hydrogeology firm will be important to the District going forward. The LBG Guyton Associates firm has an excellent reputation and has a wealth of knowledge in the North Central Texas area.

LBG Guyton Associates has represented the District beginning in 2014. The District realized an economy of scale in 2014 due to LBG Guyton Associates representing other GMA-8 districts. The proposed 2015 contract reflects that same benefit.

STAFF RECOMMENDATIONS

Staff is of the opinion that LBG Guyton Associates will continue to provide a valuable service to the District for the DFC development process. Therefore, the staff recommends accepting LBG Guyton Associates' proposal and authorizing the president to sign an engagement letter for their services.

2015 Scope of Work and Budget Estimate for Red River Groundwater Conservation District (RRGCD)

LBG-Guyton Associates

Task 1 - Support for DFC Process (Joint Groundwater Planning Process)

LBG-Guyton will attend up to five GMA-8 meetings in 2015. Time and expenses required to attend GMA-8 meetings will be split with Prairielands GCD, Clearwater UWCD, Middle Trinity GCD, North Texas GCD and Red River GCD in 2015. The budget reflects that division of costs for all districts for meeting attendance. The cost estimate assumes for James Beach and another Senior Hydrogeologist will attend each GMA-8 meeting and the time/expenses will be split between districts.

Task 2 - Technical Assistance Related to DFCs

LBG-Guyton will provide technical support to the Red River GCD for the current round of joint groundwater planning and provide technical input for the explanatory report. Subtasks for this effort will include:

- assessing technical aspects of potential and/or proposed DFCs
- evaluating modeling assumptions, production estimates and other input for the modeling runs completed by GMA-8
- serve as a technical interface between GMA-8, TWDB, and other GMA-8 districts/consultants and the Red River GCD
- Analyzing GAM runs to support DFC planning in the Red River GCD
- As needed, perform technical analysis to help assess management of the Trinity Aquifer
- As needed, help Red River GCD to facilitate stakeholder discussion in the DFC process
- As directed, assess production from aquifers based on reported or assumed well screen intervals
- Other tasks as requested by RRGCD

Please note that developing GAM pumping scenarios may require more time than is budgeted here. The budget will be on a time-and-materials basis not to exceed the budget estimate unless LBG-Guyton identifies and gets authorization to complete additional GMA-8 tasks such as time intensive GAM runs prior to undertaking that work.

Task 3 - Attend Two Red River GCD Meetings

LBG-Guyton will attend up to two RRGCD meetings in 2015 to address the board on the joint planning process, DFCs, MAGs and related issues.

CONSIDERATION AND POSSIBLE ACTION REGARDING THE DISTRICT'S LEGAL COUNSEL;

ISSUE

Consideration and possible action regarding the Red River Groundwater Conservation District's ("District") legal counsel.

BACKGROUND

Last month, the partners of the District's law firm, Sledge Fancher PLLC, amicably decided to part ways. Since the split, Sledge Fancher PLLC has changed the business name to Sledge Law and Public Strategies PLLC. Kristen Fancher has now moved to Smith, Robertson, Elliot, and Douglas LLP.

The District staff has been in communication with both of the partners, Brian Sledge and Kristen Fancher, since the split to discuss our options going forward.

OPTIONS/ALTERNATIVES

The District has the authority to choose whatever legal representation it deems is in its best interest.

CONSIDERATIONS

The District staff has discussed with Ms. Fancher and Mr. Sledge the possibility of continuing to utilize both of their services. Both Ms. Fancher and Mr. Sledge were agreeable to continuing doing business as usual, in regards to who staff utilizes for different matters, until a time when/if the Board felt it was necessary to proceed in a different direction. If the Board would like to continue utilizing both Ms. Fancher and Mr. Sledge, the District could choose to engage with both firms or continue routing all bills through Sledge Law and Public Strategies, PLLC.

STAFF RECOMMENDATIONS

The staff requests the Board provide direction on the legal representation they feel is in the best interest of the District.
