This is a judged show of works in the following mediums:
Oil, Acrylics, Water Media (watercolor & gouache),
Graphics (printmaking, drawing), Photography, Mixed
Media/Collage, and Sculpture. Artists may enter up to
three works.

Guidelines: All work must be original, not previously
shown at KIFA and not infringe upon any copyright.
Reproductions are not accepted. Sculptures must include
their own base or fit on a KIFA pedestal. Sculpture artists
must be prepared to assist in placing their work in the
gallery. Maximum size including base is: 6' high x 3' wide
and deep. 2-D works must be dry, suitably framed, wired
and ready to hang. No saw-tooth hangers. Artwork not
wired properly will not be accepted. All works on paper
under glass should have no exposed edges. Watercolor
without glass must be sealed with art wax (a good choice
is Dorlands).

KIFA reserves the right to reject works deemed
unsuitable. All entered works must remain on display
through the end of the show. Reasonable care will be
taken to ensure the safety of your artwork. KIFA is not
liable for loss or damage to artwork.

AWARDS: Best in Show, First Place, Honorable
Mention, and People's Choice.

ENTRY FEES: \$20 includes up to 3 pieces, Youth
\$2 per entry up to 3 pieces. Artwork must be
delivered May 25 - 26 (1 - 5pm). No exceptions.

DEADLINE Postmarked by MAY 23.

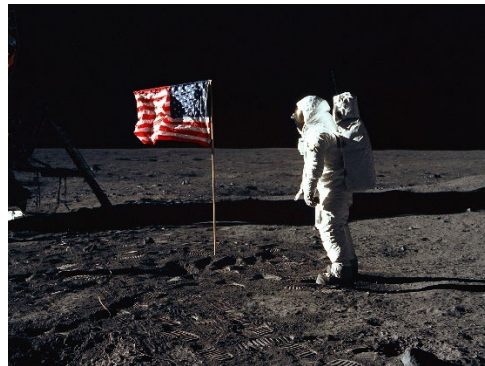

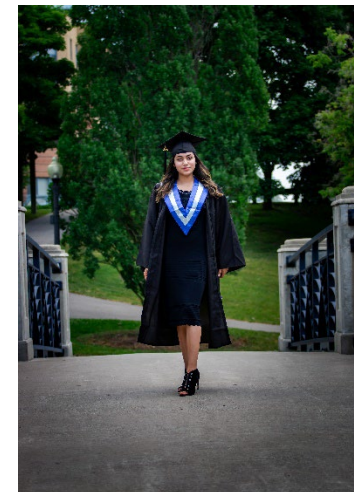
