The Lyons Township Treasurer Office’s total investment portfolio continues to outperform its benchmark (Bank of America Merrill Lynch 1-10 Year Treasury & Agency Index) with 26.04% higher returns (LTTO: 1.476% vs. BOA ML 1-10 Index: 1.171%) in the second quarter of FY2024.

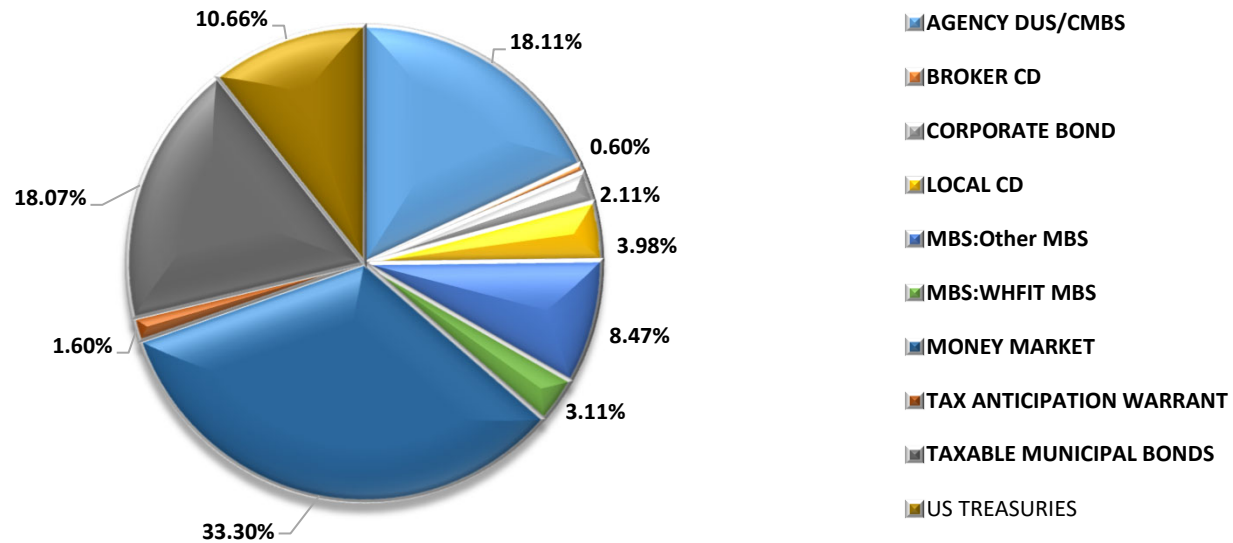

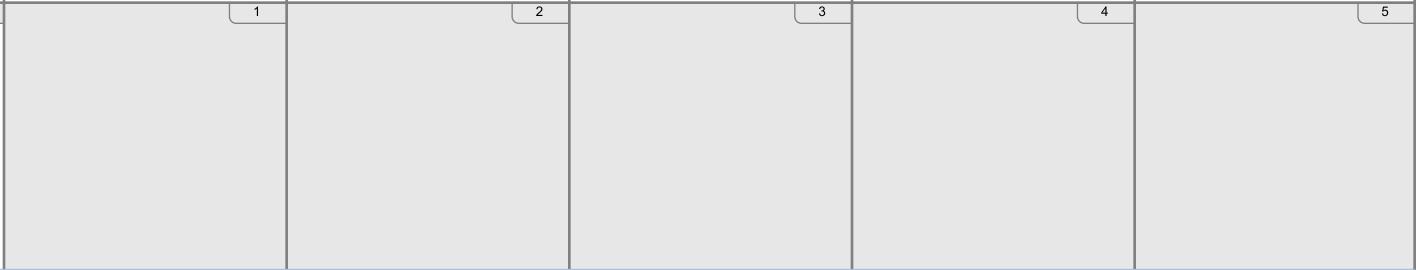
