JOB OPENING Transportation Dept. Manager

Under the direction of the Tribal Administrator, the Transportation Dept. Manager will perform research, analysis, and monitoring of activities of contracts or construction projects in support of the tribe's current and long-range planning and program implementation activities. Successful applicant must have knowledge of the Bureau of Indian Affairs Indian Reservation Road Program (IRRP), and Tribal Transportation Program (TTP) and BIA's National Tribal Transportation Facility Inventory (NTTFI) and Fixing America's Surface Transportation Act (FAST Act). Must have knowledge of the federal, state, local and tribal rules and regulations governing roads/bridges inventories, of road construction and maintenance methods and practices.

The successful applicant must have flexibility, excellent interpersonal skills, ability to follow oral and written instructions, prioritize multiple tasks and independently as needed. Must have skills in analyzing problems, projecting consequences, identifying solutions, and preparing, reviewing and analyzing technical, operational, financial reports and briefings.
