Mayor: Edwards reported that he had sent a letter to a resident asking them to remove illegally parked vehicles and they have since been removed. Streets: Thomassen reported that in addition to painting the crosswalks, there is a pot hole on Emerson Hough that needs repaired and he will contact Jasper Construction for a quote.

Sewers: DeGoey reported that Peters is not able to finish the project at the end of Walnut until another contractor finishes a job on Lynn Drive. DeGoey will follow up with the contractor to see what the delay is. DeGoey also reported that Klocke estimated that the cost to replace the remaining sewer line in need of repair could be in excess of \$100,000. He also estimated that the line could have a life span of 5-10 years. The Council discussed and decided to delay the project at this time.

Parks: Humke reported that the parks are being mowed.

Tree Steward: Fouts reported that the resident who had been notified of dead trees needing cut down had the trees removed. She also reported that there are dead limbs that need cut down in the park and will be done this fall.

Storm Sewers: Norman reported that he had cleaned out the storm sewer on Oakwood. He also reported that he will be cleaning out another storm sewer on Emerson Hough and another one on Thomas Jefferson which is also in need of repair.

City Clerk: Machin handed out nomination papers for the election coming up on November 7, 2017.
