Tuition fees are annual and payable at once by 08/31/17; or in 9 payments by Visa/MC auto-draft only.

A fee of \$30.00 will be charged for payments not honored by the bank.

A non-refundable \$56.00 fee *per costume* and \$15 Nutcracker costume rental is due November 5<sup>th</sup>.

Enrollment for Performance Classes is for the full season, September 5, 2017 through the ShowCase in May, 2017. Upon registration, **you agree to remain enrolled for the entire season, fulfilling your full tuition obligation.**

A specific uniform available through the studio is required and must be worn in order to attend a performance class.

The only method by which the early-pay discount may be taken is by full annual payment made in cash by the due date.

All other fees and payments for tuition, dancewear, costumes, etc. are non-refundable and payable via Visa/MC only.

Fees will not be pro-rated or refunded.

This form must be completed by the legal guardian of the enrolling student unless the student is 18 years or older. Please complete all spaces.
