# COWBOY MOUNTED SHOOTING ASSOCIATION

## Colorado Regulators

### General Release of Liability for Cowboy Mounted Shooting and Related Activities

Since the use of firearms and/or horses can be dangerous, all shooters and people entering the area assume all risk by signing this release.

I hereby acknowledge that I have voluntarily applied to participate in the sport of "Cowboy Mounted Shooting" and/or related activities including, but not limited to equestrian events such as the monthly shoots and trail rides and other club activities and entertainments.

As lawful consideration of being permitted to enter upon the premises upon which this event is conducted and of being permitted to participate in these activities or otherwise use the facilities, I, the undersigned, for my heirs, distribute, legal representatives, next of kin and assigns agree to the provisions set forth below:

1.) I hereby release, waive, discharge and covenant not to sue, make a claim against the property of or other to prosecute the Cowboy Mounted Shooting Association and owners of the facility used for competitions or activities, its officers, directors, shareholders, members, agents, and/or employees, (for all purposes collectively referred to herein as "RELEASEES") for liability on account of damage to the property of or injury to the person or death of the undersigned, whether caused from the passive or active negligence of RELEASEES or otherwise while the undersigned is participating in or observing the sporting or related activities of this club. **Initial here:** \_\_\_\_\_

2.) I hereby agree to indemnify and save and hold harmless the RELEASEES and each of them from loss, liability, damage or cost that RELEASEES may incur due to the presence of or any activities to be presented by RELEASEES whether caused by the passive negligence of the UNDERSIGNED or otherwise. **Initial here:** \_\_\_\_\_

3.) The UNDERSIGNED expressly agrees that this release, waiver and indemnity agreement is intended to be broad and inclusive as is permitted by the laws of the State. The undersigned further agrees that if any provision of this agreement is held to be invalid, nevertheless, the balance of the agreement shall contain in full legal force and effect.

The UNDERSIGNED warrants that the following statements are true and correct and understands that RELEASEES have relied on them in accepting this release, waiver and indemnity agreement and in giving the UNDERSIGNED permission to participate in and/or observe the sporting and other activities being conducted by RELEASEES. **Initial here:** \_\_\_\_\_

A.) The UNDERSIGNED is aware that the participation in or the observation of the sport of Cowboy Mounted Shooting with loaded firearms, equestrian handling for the events and related activities is a hazardous activity. The UNDERSIGNED does voluntarily participate in or observe these activities with the knowledge and appreciation of the danger involved, the UNDERSIGNED agrees to accept any and all risk of property damage, personal injury, or death. **Initial here:** \_\_\_\_\_
