Jack Cagle, will host a virtual public meeting on Wednesday, Mar. 23, from 6:30 - 7:30 p.m., to provide information to residents about the construction of the Cimarron Sections 2, 3, 4, and 5 Subdivision Drainage Improvements -2018.

Improvements to reduce flood risk will include replacing storm sewer with larger pipes; lowering and replacing pavement; adding sidewalks; reconstructing driveway-to-street connections in the Right-of-Way; and minor water line adjustments in locations impacted by storm sewer improvements.
