# DISCUSS PARK BOARD INSURANCE (Beaty)

Two issues about the Park Board. One was to be sure that park was insured and from everything he can determine, the park is a part of the city. The insurance company doesn't want to insure it because of the deeds to the property. He contacted DNR and they responded with an email which he thinks will take care of the problem. There are 4 deeds to that property and 3 would have to be approved through DNR. The Committee has done the research and Beaty thinks we should turn it over to the Park Board and see if they want to do it. Since it is for them, they would need to have an attorney draw up corrected deeds.

Motion by Beaty to give information to Park Board and have them follow through with it and have attorney draw up deeds to submit to DNR for approval to change deeds. Seconded by Icenhower.

# DISCUSS CITY HALL OFFICE SPACE (Beaty)

Beaty says he has gotten the impression that City Hall needs more space for storage and he heard a comment from the manager of the local branch. There are only two ways to do that, either add on or ask them to move. Says the lease is 2 more years.

Icenhower says him and Beaty spoke about this and board members should go speak to the library board and the manager here and ask what their long term plans are. Not putting pressure on them but to find out what the plan is.

Leon was told that the library would like to do something to get more room for them and Leon thinks we need to get the ball rolling. Icenhower says that the library has \$17 million.

Beaty says we should offer to sell the 2 acres behind the water department to the library.

Danderson says that we should and it should be worded carefully. He doesn't want anyone to think that the City is ejecting the library. We have grown and we just need more space. They may have a game plan that we don't know about. Icenhower says you don't know until you ask. Danderson suggest Icenhower and Beaty to go to library meeting.

Icenhower says they just wanted the blessing of the counsel to go. Consensus of the board to have Icenhower and Beaty attend library meeting. Mayor says they aren't authorized to make any decisions. Danderson says city is busting at the seams.
