Local Law No. 2 of the Year 2019

A local law to amend Section 4., Local Law #2, of the year 2017 entitled a local law establishing the residency requirements for all appointed offices for the Town of Cohocton, is hereby amended to read as follows:

Be it enacted by the Town Board of the Town of Cohocton as follows:

Section 4. Residency, requirements for all appointed offices for the Town of Cohocton.

All persons holding appointed office in the Town of Cohocton need not be a resident nor an elector of the Town of Cohocton, provided, however, that such person resides in the State of New York.


