1. I request authorization to be a NON FOR PROFIT VENDOR at the above festival date with **NO VENDOR FEE.**
2. It is agreed and understood by applicants that receipt of this document becomes a contract between the applicant and the Central Jersey Irish Festival Inc. Not with the Ancient Order of Hibernian's or the Lake Topanemus Park commission.
3. Alcoholic beverages may not be sold or distributed as per State Law. Vendors, who disregard the law, will be closed.
4. Vendors will provide their own: Tents, tables and chairs. No electric will be provided to vendors.
5. Vendors will be directed to their locations, and will place goods at designated spots. Vendors will accept locations as assigned and will only use display racks for self-supporting boards or structures that fit in their assigned area. No merchandise will be placed in the aisles.
6. Displays are to be arranged so as not to block adjoining booths and pathways. Tables must be covered with table coverings to the floor.
7. The Central Jersey Irish Festival reserves the right to refuse vendors which it deems detract from the dignity of the festival. All Vendors must be in compliance with State and local laws.
8. Vendors must assume responsibility for the safety of their merchandise and displays against loss or damage by: Fire, theft, accident or any destructive cause while on property.
9. Each vendor must provide a representative to be on hand for the sale of their merchandise and hereby release the Central Jersey Irish Assoc. Inc. from any and all responsibility for the loss, damage or monies handled at their location.
10. Any vendors arriving or setting up on Friday evening do so at their own risk. They must also call ahead for proper placement and not leave vehicles and displays in festival area. If they set up in the incorrect location, they will be asked to move their booths.
11. Storage of all extra merchandise, cartons and containers must be out of sight. We are expecting all of our vendors to present their wares in a professional manner with your name clearly displayed.
12. Vendors must be set up prior to **10 A.M.** Vendors arriving after **10 A.M.** will not be admitted and fees will not be returned.
13. Trash Removal, all vendors must bring all trash at the end of the day to the proper trash receptacles.
