Phil Green presented an opinion regarding average salaries for Development Corporation Executives and City Managers stating that he felt both positions deserved higher pay.

A. Consider and Discuss Closing E. 4th St. on October 18, 2024, at 3:00 p.m. through October 19, 2024 at 10:00 p.m. for Events Associated with CiscoTX Piefest.

Ms. Nichols said that the street closing would be a safety precaution for the vendors and play area that are set up for Piefest.

B. Consider and Discuss Approval of Cisco Development Corporation Application and Funding for High Demand Job Training Grant in Partnership with Cisco ISD, Cisco College, and Workforce Solutions.

Mr. Jaworski explained that the proposed program would bring an HVAC Certification program to the high school by providing a classroom and instruction for high school students. Councilmember C. Johnson asked for clarification on several items in the presented memorandum of understanding, including how funds are committed, total amount of grant funds in relation to matching funds, and the program timeline.

C. Consider and Discuss Approval of Cisco Development Corporation and Cisco 4A Development Corporation Budgets for Fiscal Year 2024-2025.

Mr. Jaworski presented the budgets for both corporations. Councilmember C. Johnson took exception to the four percent increase to the Executive Director's salary. He thought that instead, the Director should have only been given the contractual three and one-half percent salary increase.

Motion was made by Councilmember W. Johnson to approve the Cisco Development Corporation and Cisco 4A Development Corporation budgets for fiscal year 2024-2025, second was made by Councilmember Whetstone. The vote was as follows:

Mayor Forester asked for direction on how to send the budgets back to the corporation boards to which Mr. Jaworski commented that the authority to produce and present the Cisco Development Corporation budgets lay solely with the boards of those corporations. He further stated that the consequence of the Council not approving the budgets would be the corporations' default on financial obligations and that the Council could send the budget back, but the board had already excercised their legal authority to set the budget. Councilmembers Johnston and C. Johnson then indicated that they understood from Mr. Jaworski's statements that nothing could be done to change the budget that was presented.
