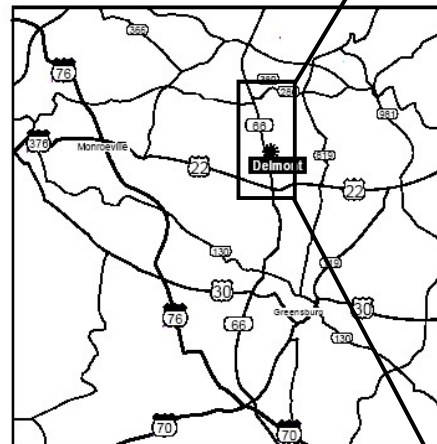

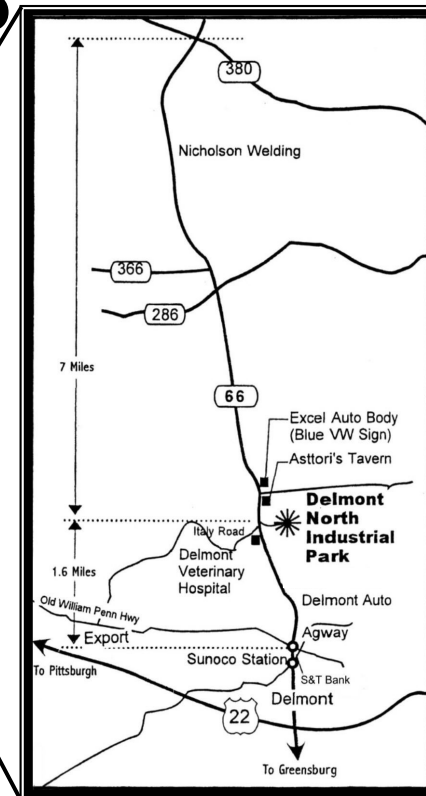

### From the West

Take PA Turnpike to Exit 57 (Monroeville.) After tollbooth take far right exit ramp toward Murrysville. Follow Route 22 East through Murrysville to intersection with Route 66 (10.4 miles.) Take Route 66 North ramp to Delmont.

### \*\*\*From the intersection of Rt. 22 and Rt. 66:

Continue north on Route 66 (2.9 miles) through two traffic lights, past Delmont Auto Sales on the right and Valero Century RV Sales on the left. Just after you pass the Delmont Veterinary Hospital on the left, turn RIGHT into driveway for the Delmont North Industrial Park. Continue to the buildings at the top of the hill.

### From the South or East

Take the PA Turnpike or Interstate 70 to the New Stanton interchange. Follow PA Toll Road 66 North to intersection with Route 22 (13.8 miles). Pass under Route 22 and follow directions from \*\*\*above.

When trial entry limit (60 entries) has been reached, a wait list will be maintained until the closing date. **Please choose RAE or RACH entry if you are not willing to accept a partial entry to the trial.**

**Make All Checks and Money Orders** payable to the Westmoreland County Obedience Training Club (WCOTC). Please mail checks or money orders with entries. Trial Secretary assumes no responsibility for cash sent through the mail.

**Telegraph, Telephone, and Unsigned Entries Cannot be Accepted.** Entries not on official AKC entry forms, or photocopies of entry forms without agreement and rules on the reverse side of the official AKC entry form are NOT ACCEPTABLE. ] **\*\*\*\*SIGN YOUR ENTRY ON THE BACK\*\*\*\***

**Entries without fees** will not be accepted. Acknowledgment of entries will be made as soon as possible after trial closes. **If a legible email address is provided, judging program and confirmation of entry will be emailed.** Paper copies will only be mailed by request. Should acknowledgment not be received by the exhibitor within a reasonable time, please notify the Trial Secretary at **724-327-2411 or LindestarGold@aol.com**

**The two Rally trials will be held in one rings. Trial 1 will start at 9:00 AM; Trial 2 will start at 1:00 PM.**

**Transfer/Move-up Policy:** Rally transfers to another class will be accepted as space permits within entry limits, in accordance with Chapter 1, Section 16 of the Rally Regulations. Requests for transfer must be made in writing and presented to the trial secretary **at least 30 minutes before the start of trial.** Forms may be downloaded from the AKC website at [www.akc.org](http://www.akc.org) or requested from the Trial Secretary.

**Post-Dated Checks and Returned checks** do not constitute a valid entry fee. WCOTC will add a collection fee of \$25 to the amount of each returned check.

**No Refund for Duplicate Entries.** Every effort will be made to find duplicate entries; however, if the entry has been processed, no refund will be made.

**Declination of Entries.** No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Westmoreland County Obedience Training Club may decline any entries and may remove any dog because of disease, viciousness, or other cause, and no one shall have any claim against WCOTC or any official thereof.

**Entry Fees Shall Not be Refunded** in the event a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the show committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entries will be made.

**Errors on Entry Blanks.** Owners are responsible for errors in the filling out of entry forms. Corrections cannot be made after the closing date. Please be certain that you fill in the right class and have the correct jump height on your entries. No entry and no entry fee will be refunded in event of such errors, or for cancellation of entries after the published closing date. Please type or print carefully on entry forms to eliminate errors.

**Bitches in Season** will not be admitted to the Trial. Any exhibitor with an entered bitch in season on the Trial date will be refunded the entry fee less \$5.00 (each day) upon written certification by a veterinarian given to the Trial Secretary before the start of judging each day.

**Exhibitors are Responsible for the Behavior of Their Dogs and/or Children.**

All dogs present must be held on leash or confined to their crates except when being judged. Exhibitors are responsible for cleaning up after their dogs. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made.

**Judges will not wait for any dog holding up a class.** Owners or agents are responsible for the presence of their dogs in the judging ring when they are called to be judged. Please plan to arrive approximately 30 minutes prior to their scheduled time of judging and leave when you are done showing. Dogs not required for further judging may be excused.

- (Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
