

**APPENDIX A

On the Effective Date, you entered into a Residential Living Agreement ("Agreement") with **Harvest Hawaii Kai LLC**, to which this Appendix A (or, "Addendum") is attached. Terms defined in the Agreement have the same meaning in this Addendum as in the Agreement.

It is our policy to have every resident covered by the E-Call System. We will provide you with one of the following devices, depending on the E-Call System that is in your Unit; an emergency response a) pull-cord; b) pendant-necklace; c) pendant-bracelet; or d) MM-pull cord ("Device"). Please indicate below the Device being assigned to You for the purposeS of the E-Call System in your Unit:

Pull-Cord; or  <sup>2x</sup> Pendant Bracelet; or  Pendant - Necklace; or  MM-Pull Cord

If your Unit's E-Call System requires an MM-pull cord, you understand and agree that you shall, at your expense have a personal telephone land-line with live service installed in your Unit immediately upon your occupancy. IF YOU CHOOSE NOT TO INSTALL OR MAINTAIN A LAND-LINE YOUR MM-PULL CORD WILL NOT WORK AND YOU WILL NOT BE COVERED BY THE E-CALL SYSTEM. IN ADDITION, WHILE YOUR SMOKE ALARMS WILL FUNCTION AND BE AUDIBLE INSIDE YOUR UNIT, THEY WILL NOT BE TIED INTO THE COMMUNITY'S SYSTEM AND WILL NOT BE AUDIBLE FROM OUTSIDE YOUR UNIT. SIGN BELOW TO ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTAND THIS NOTICE AND YOU WAIVE ANY CLAIMS THAT MIGHT ARISE OUT OF YOUR CHOICE NOT TO INSTALL OR MAINTAIN A LAND-LINE.
