

## **SCHOLARSHIP Deadline for Application: March 1, 2019**

**The Catfish Farmers of Arkansas** is an association of catfish producers, suppliers/industry-related businesses, and research/extension/education personnel involved in promoting, producing, and marketing Arkansas farm-raised catfish.

Each year, the Catfish Farmers of Arkansas awards two \$1,000 scholarships, one each for fall and spring semesters. Awards are for undergraduate (in either 2-year or 4-year programs) study and may be used for education-related expenses, including tuition, fees, books, supplies, room, and board. Recipients are encouraged to attend the annual convention of the Catfish Farmers of Arkansas and make a short presentation on their experience or interest in the catfish industry in Arkansas.

#### **Eligibility:**

To be eligible for this award, applicants must:

- Be enrolled in or have committed to enrolling as a full-time undergraduate student in a course of study for either a 2-year associate or a 4-year bachelor's degree at an accredited college or university in Arkansas.
- Demonstrate a strong interest/experience in the Arkansas catfish industry through a letter of recommendation from someone engaged with the catfish industry, either a catfish farmer, someone who provides services to the catfish industry (such as Wildlife Services or a company that provides supplies to the catfish industry), research, or otherwise involved in the catfish value chain (could include sales, promotion, catfish restaurants/catering, or others connected with the catfish industry).
- Minimum grade point average of 2.75 (high school if applicant is an entering freshman; otherwise current college GPA).

### To Apply:

- 1. Complete the attached application form.
- 2. Write and attach a 300-word essay that describes your interest in the Arkansas catfish industry.



- 3. Provide documentation that you are either currently enrolled in or have committed to enrolling in either a 2-year or 4-year program of study at an accredited college or university in Arkansas.
- 4. Attach a current transcript (college or high school for those who will be college freshmen in the fall) to verify GPA.

- 2. Explanation of your career goals and whether you would be interested in a career involving the catfish industry.
- 3. Description of your interest in aquaculture generally and catfish specifically.

# **B.** Attach a current transcript (college or high school for those who will be college freshmen in the fall) to verify GPA.
