

HAPT 2010 Annual Conference with Marie Jose-Dhaese



As most of you already know, HAPT has the questionable distinction of having had the 2nd day of its 2010 conference cancelled due to a Tsunami Warning. In pre-conference planning sessions, a natural disaster never made it on the list of anticipated catastrophes. Dr. Marie-Jose Dhaese gave an outstanding presentation on <u>Expressive Play Therapy for the Grieving Child</u>, on the first conference day, February 25th, 2010. Participants were looking forward to her second presentation. It came as a shock to all involved when it appeared that a tsunami could hit Hawaii. Cancelling the conference was delayed as long as possible, but the Pagoda Hotel management eventually made the final decision, when it shut down venue operations.

It is expected that there is a clean up process when a tsunami actually hits, but clean up when it doesn't hit???? Now that is an experience. In the wake of the tsunami that didn't hit, Chairperson Liz Kong, Cheerleader Scott O'Neal, President Nami Dolan, and an assortment of special volunteers were left to pack up. In the weeks that followed, decisions needed to be made about rescheduling the conference or refunding participants. Cheerleader Scott offered the following messages to committee and board members as communication became intense and persistent. Ever avoidant of attention, Scott reluctantly agreed to have his messages shared here.

The first article below is a summation of events. Think of it as Part II of the HAPT Story.

Aloha HAPT Members, Board, Conference Committee, and Volunteers...

It was just 3 short months ago when the question came up and preparations for the HAPT 2010 conference began. At the time we weren't sure if it would even be possible to have a conference – time was short, morale and interest seemed to be low, there was no committee, there was no speaker, the economy was bad, neither organizations nor individuals seemed to have money to attend, and the previous venue was likely fiscally unattainable.

What could possibly be done? There was clearly no way to have a conference!

But then... once a conversation was begun about if it would even be possible...

- ✤ In a week or less...
 - A member stepped forward to be conference chair and the beginnings of a committee started to take shape.
 - A speaker (extraordinaire!) was identified and agreed to come.
 - The first committee meeting was scheduled.

Within two weeks...

- A search began for a new/affordable venue.
- A member stepped forward to begin designing a new brochure.
- The process of redesigning old forms and registration materials began.
- o The first committee meeting was held and decisions and timelines were set.
- A venue was identified and secured.
- Fees were set that were both very affordable and would allow HAPT to still cover all costs.

✤ Within a month...

- HAPT members were emailed to notify them that there would be a conference and all specifics were laid out.
- o Attendee packet design was set.
- o Brochures and registration materials were finalized.
- HAPT website was updated with conference information and online registration was available.
- Flyers and registration information were mailed out to HAPT members and the community.
- A member volunteered to be vendor chair and contacting vendors was begun.
- A member volunteered to be publicity chair and began contacting community agencies to publicize the conference.

- ✤ Within two months...
 - The first online registration was received.
 - All conference details were finalized.
 - Speaker presentation and needs were finalized.
 - Preparations were begun for obtaining, collecting, and collating materials for conference participants.
 - The conference agenda and timelines were setup.
- ✤ After the third month...
 - The conference was successfully begun!!
 - The first day there were approximately 130 participants!
 - The venue was excellent ('cept maybe the food...)!
 - The speaker was beyond excellent!
 - Everything was organized and well prepared!
 - Everyone was excited and energized and looking forward to the next day!

And then there was an earthquake in Chile and tsunami warnings in Hawaii. And there was a decision to postpone and finally cancel the conference. And there was fear, confusion, sadness, disappointment. And still...

- HAPT board, committee, and volunteers members stepped up to immediately email and phone attendees to spread the word and make sure people didn't risk safety to come to the conference site.
- People were on-site to assist attendees who didn't get the word and who did show up at the hotel.
- There was excellent communication between the board, committee, the speaker, and the hotel to make sure everything was taken care of as much as possible.
- Offers were made to house off-island attendees in case this was needed.
- Not one complaint was received about the cancellation instead attendees only had words of support, appreciation, and gratitude.
- And when it came time to clean up the hotel and close out the conference, members and friends were again there to help out – with their hearts, positive spirits, and laughter.

At the end of it all, as I look back on this whole process and time, at the energy and love each individual has spent on it, I feel nothing but amazement and appreciation for each of you and everything you gave to this conference. It is due to each and every one of your efforts that this years conference was as much of a success as it was – and have no doubt, this was nothing short of a MAJOR success and accomplishment!

As a group we put together a conference to be proud of, that attendees were not only able to learn from but also felt "taken care of, cherished, and re-energized" (told to me by one attendee). When the odds were against us and it looked like there was no way for this to happen, people came forward and made it happen – not out of a sense of obligation or desire for personal advantage – but out of a love of what we do and the communities we serve.

And that's what makes HAPT special... That's what makes each of you special... And that's what everyone feels when they attend HAPT functions.

And for all the above, I thank you all. As always, though this year I suppose I can't say it was "all a piece of cake", being involved with this organization and having the opportunity to work with each of you on this was worth it and I look forward to HAPT's next venture..!

In this day long workshop, Barbara Turner will examine wounded attachment patterns within the context of determining the child's level of attachment and readiness for sandplay. In a presentation that bridges Sandplay Therapy and Play Therapy, participants will actively engage in treatment planning and play therapy strategies that utilize the therapeutic tools of Agnes Bayley, an early innovator in working with attachment disorder, as well as interventions from Dr. Turner's own work.
