TOWN OF GREENWOOD MINUTES OF THE WORK SESSION OF THE MAYOR AND BOARD OF ALDERMEN

Thursday, January 12, 2017-6:00 PM

Mayor Frank called the meeting to order at 6:00 pm , Alderman Robinson then led the invocation and Pledge of Allegiance.

Staff Reports:

Town Clerk, Veronica Brown gave information in regards to the upcoming events;

- 1) 2017 Calendars were distributed, a joint project of the Town and Greenwood Chamber of Commerce
- 2) Advised that the Regular Session would be on Tuesday (instead of Monday) due to an upcoming holiday. Also, the Agenda will have a Resolution which was received too late for the Work Session.

Town Attorney, Charles Grubb, gave an update and timeline on the Employee Personnel Ordinance. The Council can expect to see an updated Ordinance in March of 2017

Police Chief Shayne Gibson, there was one (1) use of force of incident in the month of December. Chief Gibson also provided information on the Operation Santa project which helped approximately 97 kids (representative of over 40 families). Last, he provided information to the Board and Public on a Public Safety Fair to be held on March 18, 2017 in William Peters Park from 10AM until 2PM.

- 1) Waterplant Construction Meeting to be held Thursday, January 19th. It appears we are sixty (60) days out from the completion of the waterplant expansion
- 2) Updated information on a new light pole at the intersection of 70th Street & Hwy 80. Mayor Frank to work with AEP/SWEPCO for pricing information
- 3) Sewer issue on Beebe, LRWA has been requested to run a camera through the sewer and diagnose the issue
- 4) Waterwood Sewer extension, bid has been completed and job was awarded to Pulley Construction
- 5) Bid process for the Waterwood lift station has begun and the first of three series has been posted in the Times
- 6) Mayor Frank recognized Officers Lee, Maples & Rothery for services for the Community which displayed "over and above" attitudes
- 7) Planning & Zoning Board needs an additional member and the Aldermen were asked to submit names for an appointment.

8)Mayor Frank then asked Alderman Robinson to give a brief overview of the upcoming Chamber of Commerce Meeting and the initiative of creating our community identity. Alderman Robinson did accordingly.

Ken Bardett gave information in regards to brown water issues and advised of some upcoming scheduled shut downs at the water plant
