ON THE PROPOSED RATE RESTRUCTURE AND INCREASE IN WATER RATES  
AND CHARGES FOR WATER SERVICE AND OTHER RELATED FEES

**NOTICE IS HEREBY GIVEN**, that the Board of Directors of the Apple Valley Heights County Water District will hold a public hearing, to receive public comment on its proposed increase in its fees for water service provided by the District. The public hearing will be held on July 10, 2018, at 6:00pm at the District office, located at 9429 Cerra Vista Street, Apple Valley, Ca 92308

The proposed increase is needed to meet the operating expenses of the District and maintain water sustainability. The proposed rate and fees are listed below:

**Current Water Rates**

\$40.75 Base Rate includes 0-300 cubic feet  
\$2.00 Surcharge  
\$10.00 Capital Improvement Fee  
\$3.50 per unit for 400-900 cubic feet  
\$3.60 per unit for 1000-1900 cubic feet  
\$3.70 per unit for 2000-2900 cubic feet  
\$3.80 per unit for 3000-3900 cubic feet  
\$4.00 per unit for 4000+ cubic feet

**Proposed Water Rates**

\$30.75 Base Rate includes 0 cubic feet  
\$5.00 Surcharge  
\$10.00 Capital Improvement Fee  
\$3.70 per unit for 0-900 cubic feet  
\$3.80 per unit for 1000-1900 cubic feet  
\$3.90 per unit for 2000-2900 cubic feet  
\$4.00 per unit for 3000-4900 cubic feet  
\$5.00 per unit for 5000+
