- 1. Patrick Miller welcomed everyone to the meeting.
- 2. Approval of November 26, 2018 Minutes: Motion: Ken Meyer; 2nd: Alycia Galvin; all in favor
- 3. Financial Reports
 - Local Drug Free Communities Fund
 - 2018 collections: November \$2,910.23; December \$4,554.79 YTD: \$50,658.69
 - Expenditures: See Treasurer's ReportFY20 grant amount: \$92,797.54
- **4.** News Around the State and Nation: The report was attached to the agenda.
 - Fentanyl was involved in almost 29% of all overdose deaths in 2016, making it the most commonly used drug involved in overdose fatalities, according to the CDC.
 - The average five-year cost for using heroin 10 times a day is \$318,500. People who smoke 10-19 cigarettes a day will spend an average of \$5,000 over five years.
 - A new study finds one-fourth of people who take prescription opioid painkillers for long periods are at risk of an overdose from unsafe combinations of prescription medications.

5. Guest Speaker: Barb McKee, Positive Resource Connection (formerly AIDS Task Force)

- Individuals with an HIV diagnosis are assigned a case coordinator who can assist with food, housing, medical appointments, etc.
- Prevention and outreach help the community understand the risky behaviors and treatment options. The Bowen Center and Park Center offer support groups. Parkview Behavioral Health offers youth support groups.
- Free confidential testing is available for HIV and STDs. The Positive Resource Center visits
 Adams County on a quarterly basis. HIV results are ready in 60 seconds. If an individual is
 positive, additional confirmation testing is completed. Walk-in or appointment testing is
 available.
- Treatment has made great strides in the last 30 years. If individuals follow their medication regimen, they often will not progress into AIDS.
- The top two riskiest behaviors include injection drug use and sex with multiple partners.

- Regarding Hepatitis C, 15-25% of those infected can clear the infection on their own.
- Hepatitis C is known as the Silent Killer. HIP 2.0 will pay for medical care for individuals with liver disease if they have been drug-free for six months.
- Truvada is a medication that treats Hepatitis C and is taken once a day.

• FY19 Grant Approval

• All approvals have been secured. MOUs will be distributed soon.

• Recovery House

- Oxford House is run by residents in the home without a house manager.
- The house votes in a president, vice-president, secretary and treasurer.
- A single-family residence is sufficient and does not require special zoning.
- Oxford House will buy the home, but public transportation must be available. Discussion included bikes and volunteer drivers. Golf carts could also be an option and would require certification. A driver's license is also necessary.
- o Serenity House is not licensed but more structured. The House Manager is on-site on weekdays and sometimes on weekends. Steve Smith, Executive Director of Serenity House, will attend the next Recovery House meeting.
