BITCHES IN SEASON

Bitches in season (BIS) MAY compete at Barn Hunt trials. They will be run at the end of each class. BIS must wear pants/britches at all times when not being pottied, including on the course.

Owners of BIS should seek out the chairperson upon arrival to be parked in the BIS parking/walking area. Advance notice is greatly appreciated!

Failure to notify the Trial Sec, Club and fellow competitors of a BIS results in a disqualification and dismissal from show grounds.

REFUNDS AND WAITLISTS

Entry Fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire,

and act of God, public emergency, act of a public enemy, or any other causes beyond the control of the organizing committee.

Full refund given if pulled before closing OR after closing*IF* there is a waitlisted dog waiting for the spot. If there is NO waitlist for the day- there will be no refunds given if the dog is pulled POST closing date.

GENERAL EXHIBITOR INFO

Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then you cannot enter the Instinct Test.

Any dog (regardless of level) can enter and run Crazy 8s. Read the class rules on the Barn Hunt website.

Move-ups will be accepted until 30 minutes BEFORE the start of each trial. You must sign a move-up form at the Secretary's table- please pay the class difference at that time (if applicable)

There is no crating indoors. Come prepared for NY weather! The blinds are outdoors!

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups when possible.

Height Divisions: Small, Dogs 13" & under; Medium, Dogs 13.1" to 18"; Large, Dogs over 18".

All dogs must be on leash at all times except when in the ring for judging. You must be mindful of other exhibitors and keep your dog close to you. Altercations are subject to Barn Hunt rules and can result in teams being ejected from the trial or being banned from the sport. PLEASE WATCH YOUR DOG AND GIVE DOGS SPACE

NO FLEXIS, HEAD HALTERS or ECOLLARS IN USE.

Exhibitors are responsible to clean up after their dogs.

Exhibitors are responsible for being ready to go to the staging area, in the staging area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class.

A & B CLASSES IN Barn Hunt

B classes are offered for this trial and ALL Central Bark 2019 Trials. For rules on the B classes see barnhunt.com. There is a nice flow diagram that will help explain what you need to enter.

You can run A classes OR B classes on a weekend. You cannot switch between A and B for the duration of the weekend. For instance *if* you are running A classes on a weekend and finish your title you must move up to the NEXT A class OR stay in the A class you finished for a "bumper leg".

You may enter any B level class for which you have already titled. If you are working on a Senior A title (for instance you do NOT have the RATS title yet) you may run Novice B or Open B.

If you have a RATM and are working for the RATCH- you must be in the B classes.
