Should we find that your counseling needs are outside my areas of expertise, I will make an appropriate referral for you.

# **Confidentiality**

Our relationship together is based on trust. What you say and do during our time together remains confidential. However, there are some circumstances during which I am permitted and ethically responsible to break confidentiality. These circumstances include endangerment of self or others.

In addition, when appropriate, I consult with other career professionals in order to provide you with the highest caliber of professional service. In those situations, I will disguise your identity.

You have the right to terminate our relationship at any time and for any reason.

#### <u>Fees</u>

My established fees of \$125 per 60-minute session are based on similar services provided by other career professionals in the area. Payment of cash, check, or credit card is due at the conclusion of each session. In the event that my established fees become a financial problem, please discuss the matter with me, and we will try to find an alternative.

If you are unable to attend a session, I require at least 24 hours notice or a fee will be charged for the missed session. I typically do not make appointment reminder calls, so please note your next appointment date and time.
