Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at <u>LKSAGE@aol.com</u> or by phone (503) 632-2227(home) or (503) 840-4303 (cell).

Unfortunately, due to low entry numbers we have made a judge change. LaVar Griffin will now be judging all classes all three days. <u>Dan has graciously allowed us to run his courses</u> though and I greatly thank him for that. If you wish to withdraw your entry because of this judge change, you may do so and receive a full refund <u>for the classes affected</u>. Because of this change we are adjusting the class run order to make for a more efficient running trial.

SITE INFO: This trial will be held in two rings indoors on packed dirt. There will be crating on the area outside the arena, around the bleachers. Crating space is somewhat limited, so we ask that you please conserve on space so that everyone who needs crating will be able to find a spot. Please bring chairs, crates, water and clean up tools for your dogs. You may set up your crating space Friday morning beginning at 8am. If you set up prior to 8am, we reserve the right to move your space in order to set up the secretary tables and raffle area.

DIRECTIONS TO THE TRIAL SITE:

From North of Eugene

Travel south bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7th Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11th Ave. at the light. Turn left on Tyler Street and travel to 13th Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

From South of Eugene

Travel north bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7th Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11th Ave. at the light. Turn left on Tyler Street and travel to 13th Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

ARMBANDS: If you marked that your dog has a permanent height card, armbands will be available for pick up at the trial secretary table each morning in binders, alphabetical by Handler's Last Name. If you don't see your armband(s), then your dog needs to be measured or show a height card. There is no formal check-in. There will be new armbands each day. Please check in with the gate steward prior to running in your class.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

MOVE-UPS: The deadline for move-ups is Monday, April 18, 2016 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

VOLUNTEERS: You, the volunteers, help make our trials a success. In an effort to keep entry fees low for you and yet help the clubs bottom line, we will be offering a <u>DAILY worker raffle</u>, The workers raffle will be drawn each day in the early afternoon. Prizes must be claimed by the conclusion of the trial on Sunday.

Thirty minutes after the trial ends on Saturday, there will be a B match. A B Match runs exactly like a show, but with no scoring. You may use toys and you can train in the ring. There will be a time limit per run of 90 seconds. The cost is \$5.00 per run. You must fill out an entry form and entries will be taken day of show. The dog does not have to be entered in the show to run in the match.
