BOARD MEETING MINUTES May 9, 2017

In Attendance

Officers and Directors: Bob Keighley, Karl Law, Timothy Reilly, Linda Welsh, Ronald Brooks, and Linda Dion. Residents: Lou Aviola and Greg Ritter

Approval of Minutes

Minutes of the February 14, 2017 Board Meeting were approved as written and posted to LambethRiding.org.

Treasurer's Report

Treasurer, Tim Reilly presented a written report. It is attached to these Minutes. It was approved as written. **Dues:** Most households have paid their dues for the year and their one time assessment for the camera at our front entrance. **Road Snow Removal:** Del Dot reimburses 75% of cost of snow removal that is over 4 inches deep. Snow removal costs were low this year. Since this made extra funds available, \$500 was transferred to the Major Maintenance and Repair Account.

Old Business

Front Entrance: Despite the large No Solicitation sign at the front entrance, solicitation is going on. You can calmly remind folks who ring your bell of that and encourage them to leave the community. Then do not let them engage.

Front Entrance Cameras: A record is kept for 30 day of all cars entering and leaving the community. Then it is erased / filmed over. It is not reviewed unless someone reports a problem and has the date of the problem. In that case, it can go to the police.

North West Delaware Crime Watch Network – Karl Law and Linda Dion screen reports from this organization, and decide what needs to be sent out to our community. This seems to be working O.K.

Front Entrance Maintenance contract Proposal: Karl Law headed this committee, and sent out 4 bids soliciting front Entrance Maintenance Contracts for the year. Three of the four responded, and the committee recommended McDonald Landscaping. One price was significantly higher, and McDonald did the best job of communicating with the committee. Karl Law's recommendation was accepted unanimously.

Road Repair Status: Bob Keighley reported that some repairs have started to the road gutters. All of Lambeth Place, Cain Rue and some of Norman's Lane will be resurfaced. Del Dot handles the small stuff and the bigger stuff goes through our state representative, Joe Miro. Concerns can be addressed to Bob Keighley through <u>mailto:board@lambethriding.org</u>

Waste Removal Update: Ronald Brooks is the Board contact for the Charter Oakes Co-op contract with Allied/Republic. Thirty-three households have signed up for yearly waste pickup and recycle service. Changes, status, and problems can be communicated directly to them, not sent to him.

Questionnaire Status and Results. Linda Welsh, Board Secretary, developed and sent out to households, by email, a questionnaire about community social activities. Some of us have been wondering if this part of our mission is still needed. Most events have low participation levels, and attract only the same folks year after year. The questionnaire was sent out on 4-8-17, and a reminder sent on 4-12-17 along with the Garage Sale announcement. Ten responses were received.

Only the Garage Sale and the Wine Tasting generated mostly positive responses: Annual Picnic: 5 yes, 5 no Winter Holiday Party: 5 yes, 4 no Holiday Caroling: 4 yes, 5 no Visit from Santa: 4 yes, 4 no Spring Community Garage Sale: 9 yes Wine Tasting Party: 7 yes 2 no

There was some discussion, including the thought that Linda had missed some questionnaires that were returned. She had them sent to her, and they may have just gotten lost, since they were from unrecognized addresses. It was suggested that she send it out again, with responses sent to the board rather than her.

Garage Sale: Eleven households signed up to participate, several at one site Success as shown by actual sales varied tremendously. The early birds arrived as usual and at midmorning Cox Road close to the entrance was very congested. **Many thanks to all who participated**, **and especially to committee members. Bev Hite** posted signs at our entrance several days ahead, and at both ends of North Star Road. **Nancy Moore** put balloons up very early at the front entrance and at every house that participated. **Linda Welsh** had adverts posted in the News Journal and Hockessin Community News, both online and print editions. The LRHOA paid for these and for the balloons. Linda also made and deployed two large posters inside our front entrance encouraging residents to sell, buy, or just visit.

New Business

Some community concerns were discussed, including traffic, speeding, picking up after dogs, and barking dogs, conditions that foster mosquitos, deed restrictions, and where cars are parked.

A **Nominations Committee** is being formed to provide a slate of candidates for next year's LRHOA Officers and Board. Contact Bob Keighley or Karl Law to be part of this committee or to volunteer your services as a candidate.

<u>Santa's Visit:</u> A belated note of thanks to Santa and his helpers, **James Sammann** and **Nancy Stearns** for their visit to neighborhood children on December 15, 2016. Q2 2017 TREASURER'S REPORT & ANALYSIS

As of May 9, 2017

TREASURY ACTIVITY:

The current Checking Account Balance is \$8,786.00. The bank account has been reconciled monthly; no errors have occurred.

The current Savings Account Balance is \$2,301.87. Statements for this account are received quarterly and are forwarded to all Board members.

The year-to-date Treasurer's BVA Report and Account Activity Reports are attached. Specific items are discussed in later sections of this report.

2017 COLLECTION OF DUES:

So far 61 of 62 homes have paid their dues. \$6,100 has been deposited into our checking account. <u>There is still 1 household who has not paid the 2015 \$35 special assessment fee.</u> <u>2016 dues \$100 and 2017 dues \$100 (Past due \$235).</u>

LRHOA REGISTERED AGENT:

The registered agent was updated to Tim Reilly. Cost of the change was \$5.00.

MAJOR MAINTENANCE & REPAIRS

A \$500 deposit was made on 4/3/17. One transaction per year is required for the account fee to be waived. With the low cost of snow removal this season, we can consider transferring another \$500.

SNOW REMOVAL:

We had (3) storms this year with a total cost of \$1,925.00. DelDOT reimbursed us \$581.25, so net costs were \$1,343.75. This is below our 10-year average net cost of \$2,212.00.

DIGITAL ARCHIVES:

The Go Daddy On line file storage is up and running. The service was paid for 3-years to get the most competitive price.

All historical paper archives have been professionally shredded.
