

PUBLIC NOTICE FOR THE OPENING AND CLOSING OF THE WAITING LIST

THE HOUSING AUTHORITY OF THE CITY OF FORT LAUDERDALE WILL BE ACCEPTING APPLICATIONS FOR THE SECTION 8 HOUSING CHOICE VOUCHER WAITING LIST

Preliminary applications must be completed online beginning Monday, March 25, 2024 at 9:00 AM. The applications will be closed on Friday, March 29, 2024 at 5:00 PM. To be eligible to be placed in the waiting list, the Head of the Household <u>MUST</u> be 18 years of age or older. The total household annual gross income <u>must not</u> exceed the *very-low-income* limits for the appropriate family size as listed in the Income Limits Table appearing at the end of this Public Notice.

If you wish to apply, you will need to logon to <u>https://housing.hacfl.com/</u>and follow the application wizard ensuring that you complete <u>all</u> the required fields or the application will not successfully be submitted at the end.

Pre-Applications WILL BE ACCEPTED ONLINE <u>ONLY</u>. Pre-Applications must be completed beginning Monday, March 25, 2024 at 9:00 am and ending Friday, March 29, 2024 at 5:00 pm. Hand delivered or Mailed applications <u>WILL NOT</u> be accepted.

For the Section 8 Waiting List: All completed pre-applications submitted online will be entered into a random lottery drawing where 3,000 names will be selected to be placed on the waiting list. <u>We will select only 3,000 names</u>. Remaining applications not selected by lottery will be discarded with no further notification. If selected as one of the 3000 applicants, you must submit all changes of address and income in writing to: Housing Authority of the City of Fort Lauderdale Waiting List, 500 West Sunrise Boulevard, Fort Lauderdale, FL 33311, or <u>intake@hacfl.com</u> immediately.

- >> Placement on the waiting list will be determined by the lottery.
- >> Duplicated applications will be removed before that lottery process is performed.
- >> Incomplete applications will not be submitted.
- Only Applicants who meet the criteria of <u>Non-Elderly Disable (Age 18 Age 61)</u> should select that preference on step 12 of the application process. Proof of the selected preference will be required.
