Please note that the above referenced list is intended as a guide and not a set of requirements. Honor Society Professional Membership will be granted on a case by case basis, taking into consideration all personal achievements. The applicant's achievements may include some, none, or all of the aforementioned examples.

The following professional criteria **MUST** be satisfied at the time of application:

- 1. At least 5 years full-time work experience within the Homeland Security, Intelligence, Emergency Management or any Protective Security Sector; and
- 2. A proven commitment to the protection of people, information, assets, or the community at large; and
- 3. An affirmation to abide by all laws, rules, regulations, requirements and restrictions of the United States of America and its Constitution.

Your completed application package must be accompanied by a check or money order made payable to the **"Order of the Sword and Shield.**
