The City Council of the City of New Munich met in regular session at 6:31 p.m., in the City Hall. Shawn Duevel, Elmer Boecker, Sandy Zierden, Kurt Thelen and Ron Doll were present.

On a motion by Sandy Zierden, seconded by Kurt Thelen and carried the minutes from June 6, 2022 were approved.

Fire Chief, Al Fiedler was present. 5 Medical calls for the month. Did not get hydrants flushed. 1 bill submitted for EMS Refresher for \$2650.00.

Waste/Water Operator, Tom Valerius was present. Water-pumped a little higher than normal. Draw downs in both wells are both in normal range. Waste-ponds were sprayed for weeds. Bills submitted-Travel, 2 light bulbs for pump house and some hornet/wasp spray.

Building Permits—Josh Poepping-Add cement slab 25x25 north side, 15x24 diagonal slab east side, 4 ft apron on S, W, E of the house. Backwoods plumbing and heating-Eliminate door on east side, window south side. Add 14x10 overhead door south side, apron and driveway south side 15x32. Tree of Life has an 8 foot fence. Will need to reduce height to fence or apply for a variance. Contacted Susan city attorney to find out what needed to be done.

Roger and Steph Boecker asked about getting a piece of land annexed into the city. Will need to reach out to Oak Township.

Resolution 7-22-A, Establishing Old TH 237 as a County State Aid Highway. Ron Doll made motion, Kurt Thelen 2nd. Motion carried.

Resolution 7-22-B, Lions Fall Calendar Raffle 2022. Ron Doll made motion, Kurt Thelen 2nd, motion carried.

Was brought up that 5th Ave West gets really tight for vehicles and it's already a bad corner not that the Bavarian Gardens is open. Council talked about doing no parking on one north side of the street. Elmer Boecker made motion, Sandy Zierden 2nd, motion carried. Signs will get ordered and posted.

Council discussed about putting water/sewer payments for 511 Main Street onto their property taxes. Also charges for snow plowing their sidewalks. Talk to Susan about sending letters to them. Also need to send letter about weed control and mowing.

Audit is still in process will be working on preparing the financials

Elections in November- Mayor seat and 2 council seats will be up for election.
