President Trump's Executive Order – a Misnomer About OUR SERVICE – the USPS By: Kathy Danek - President

In case you missed it President Trump issued an executive order – on April 12, 2018 to evaluate the finances and operations of the USPS. In his tweets prior to the executive order, Trump assailed the business relationship between the USPS and Amazon, citing the package delivery and how Amazon is cheating the USPS. He further claimed that the USPS is bleeding money and Amazon is to blame.

The Executive Order calls for a full report within 120 days to provide a "thorough evaluation of the operations and finance" of the USPS to include:

- the expansion and pricing of package delivery
- the USPS role in competitive markets, the decline in mail volume, and implications of USPS financing
- the USPS monopoly over letter delivery and mail boxes
- the USPS business model, workforce, operations, costs and pricing.
- According to Bloomberg view columnist Joe Nocera, "Though the president won't like to hear this, Amazon has

played a big role in helping the USPS cut its losses. The Service's Postal package business grew in both volume and revenue by more than 11 percent, while its mail volume fell by 3.6 percent. A task force that looks seriously at the Postal Service's problems is far more likely to recommend that it



raise the price of a first-class stamp than charge more in its fastest growing segment"

But the real issue is the 2006 Postal Accountability and Enhancement Act requirement to prefund retiree health benefits for 75 years over a 10 year period. The PAEA basically demanded a 5.5 billion dollar prepayment beginning in 2007 – which equates to \$55 BILLION for retirees who have yet to be born. No other government agency or private sector company is required to meet these draconian future financial burdens. Yet, we have not seen Congress look to fix their inept 2006 PAEA law.

The American Postal Workers Union issued the following statement: "The APWU looks forward to working with anyone truly interested in maintaining a vibrant public Postal Service for generations to come. If given the opportunity to meet

Your Post Office Receives ZERO Tax Dollars

- **FACT:** The United States Postal Service (USPS) receives no tax dollars for operating expenses and relies on the sale of postage, products and services to fund its operations.
- **FACT**: The Post Office is established in the U.S. Constitution. The public Postal Service is part of the fundamental infrastructure of this nation binding it together.
- **FACT**: The United States Postal Service delivers to every address in the country –157.3 million addresses no matter who we are or where we live. In contrast, private delivery companies go where they can make a profit.
- **FACT**: The Postal Service is consistently the most trusted U.S. government entity. It rates highest among young adults.
- **FACT**: While letter mail volumes have been declining, a lot of mail remains. The Postal Service processes and delivers 493.4 million letters and packages each day.
- FACT: Package volume is increasing. In these days of rising e-commerce and on-line shopping, the public Postal Service is as needed and relevant as ever.
- FACT: The U.S. Mail is the most secure and private form of communication.
- **FACT**: Financial hardships for the USPS were manufactured by the 2006 "Postal Accountability and Enhancement Act." This Congressional action forced the Postal Service to "pre-fund" future retiree health care costs 75 years into the future. No other agency or company faces this financial drain. The unfair burden is directly responsible for the reduction in the hours of operation, staffing, mail speed, and the quality of postal services.
- **FACT**: Congress should fix the problem they created by passing postal reform legislation that ensures the public Postal Service remains vibrant for generations to come.

In order, to be seated, as a delegate and able to vote on any issue during the National Convention, the per capita tax must be received by the National Treasurer at least 20 days (July 31st) prior to the opening of the National Auxiliary Convention (August 20th). Dues must be paid current through the first day of the month following the National Convention (September 1st).

Enhance your experiences, take a chance and be a member of one the many committees needed to maintain our Auxiliary. Committees not only enable you to learn more about your organization, but they also introduce you to members from across the nation to share ideas from your own states and locals. Many lifetime friendships share a beginning at a National Convention committee meeting.

The Committees are:

- Resolutions Constitution
- Resolutions Miscellaneous
- Consolidated Report
- Rules
- Political Action
- Courtesy and Greetings
- Auditing and Finance
- Nominations and Elections
- Human Relations
- Planning and Ideas
- Credentials

For those of you who enjoy learning about the guidelines of the Auxiliary you might like the <u>CONSTITIUTION AND BY-LAWS COMMITTEE</u>. Resolutions come from all over the country, as well as our Executive Board. The committee studies these resolutions and can recommend them for consideration by the entire delegation or kill the resolutions in their committee. The committee may also suggest their own substitute amendments to the delegation.

<u>MISCELLANEOUS RESOLUTIONS</u> are also submitted from across the nation. Those resolutions included such things as the new logo, endorsements of political candidates, the TWO-CAN-DO projects, Labor Education, legislation and so on. Both resolution committees give you the opportunity to learn how to write a resolution, amend a resolution and support or defeat a resolution. For those with a political interest perhaps the **NOMINATIONS AND ELECTIONS COMMITTEE** is your forte. Your responsibilities include setting up the nominations according to the Constitution, putting together the ballot, running election and making certain each delegate receives the proper number of votes as accorded by the Credentials committee. You then count the votes and present the elected officers and vote tallies to the delegations.

CREDENTIALS COMMITTEE The is responsible for the assignment of appropriate voting strength for each delegate. Upon arrival at the convention, delegates are asked to present credentials bearing the signatures of the President and Secretary of their state or local Auxiliary. The Treasurer verifies the dues. After all of this the delegates are seated (allowed to be on the convention floor and vote). A daily credential report of the number of delegates present and voting strength is given to the delegation. Guidelines for the voting structure are in the National Auxiliary Constitution and By-laws.

Financial wizards may prefer to be on the <u>AUDITING AND FINANCE COMMITTEE</u>. An independent audit of the National Auxiliary Treasurer's books is done and presented to the convention. The committee looks over the books and records as well as the auditor's report and reports back to the convention their findings. The Finance Committee also makes recommendations that could be helpful to the National treasurer.

For those who want to know everything that went on in the past two years, consider being on the <u>CONSOLIDATED REPORT COMMITTEE</u>. They look over the prepared consolidated reports of the officers and committees from the National Auxiliary Executive Board.

<u>RULES COMMITTEE</u> members meet to decide the schedule of convening and recessing each day of the convention. Rules for delegates' participation at the convention are also a responsibility of this committee. Usually rules from previous convention are submitted to the committee for them to study, amend and recommend to the delegation.

The **POLITICAL ACTION COMMITTEE** members use innovative ideas to raise additional COPA dollars from the Auxiliary. Other legislative activity may also be directed from this committee.

Teens Often Think E-Cigs, Hookah Pipes Harmless: CDC

Teenagers who use tobacco products other than cigarettes often see their habit as harmless, a new U.S. government survey finds. The report, from researchers at the U.S. Centers for Disease Control and Prevention, asked teenagers whether they considered themselves tobacco users. It turned out that kids who favored products like electronic cigarettes, hookahs (water pipes) and smokeless tobacco often failed to see themselves as tobacco users.

Even among teens who agreed that "all

tobacco products" are harmful, there were many who thought their product of choice wasn't. That included threequarters of kids who used e-cigarettes, and 56 percent of those who used hookahs. "Teenagers might not realize the products they use contain nicotine and are addictive," said Erika Sward, assistant vice president of national advocacy for the American Lung Association. That means education efforts have to do a better job of tackling the products that are popular with kids these days, Sward added. "We can't just be talking about cigarettes anymore," she said. However, the U.S. Food and Drug Administration announced on Thursday that it plans to try to lower the amount of nicotine in cigarettes to make them less addictive.

The CDC report comes from a survey of over 20,000 U.S. middle school and high school students. Overall, 558 kids said they'd used e-cigarettes in the past month. But 60 percent did not consider themselves a "tobacco user." The same was true of over 80 percent of kids who used "roll your own" or pipe tobacco. Similar patterns were seen among students who'd smoked only cigars or hookahs.

Meanwhile, there was a disconnect between what kids thought of tobacco products as a whole, and how they saw their product of choice. Of kids who used e-cigarettes, most (80 percent) agreed that "all tobacco products" were harmful. Yet only 22 percent thought e-cigarettes were risky. There was a similar disconnect among kids who used hookahs or smokeless tobacco.

A hookah is a large water pipe that uses charcoal to heat tobacco, which may be sweetened or flavored. Hookah "lounges" are popular, and Sward said many young people may see hookah smoking as a social activity, rather than



tobacco use. As for e-cigarettes, she said, kids may not consider them tobacco products because they are smoke-free. But e-cigarettes do contain nicotine -- which, Sward said, can affect the developing adolescent brain and cause addiction. "Kids who use e-cigarettes are more likely to go on to smoke combustible cigarettes," she noted. On top of that, the U.S. Surgeon General has warned that e-cigarettes may contain other harmful substances -including heavy metals and ultrafine

particles that can be inhaled deeply into the lungs.

According to study co-author Dr. Israel Agaku, a researcher with the CDC's Office on Smoking and Health, "Youth use of tobacco products in any form, including ecigarettes and hookahs, is unsafe." The CDC report was published online March 15 in the journal Pediatrics. It's important for adults to set a good example by being tobacco-free, Agaku said. And it's up to everyone -parents, teachers, doctors -- to talk to kids about the risks of all tobacco products, he explained. Sward added, "We've had this problem for years with smokeless tobacco," referring to kids' misperceptions that it's "safe." Now, she said, there are additional products, including ecigarettes and hookahs, drawing kids in. "Parents need to be aware that these products have a vice grip on kids today, the way cigarettes had on [their generation]," Sward said

Guidelines for Raising and Spending COPA Funds

Giving to COPA is a very effective way for APWU members to make our voice heard in Congress.

Through COPA, our union's active and retired members can pool our resources to help elect legislators who will stand up for postal workers and retirees. This is especially important in protecting postal jobs, wages and benefits amid the ongoing postal "reform" debate. COPA dollars also help elect politicians who will defend Social Security, Family and Medical Leave Act benefits and collective bargaining rights for working people everywhere.

There are many ways to run an effective COPA campaign, but there are a few guidelines we need to follow to comply with the law. Here is a brief list of a few "Dos" and "Don'ts."

Summary of Regulations Governing COPA Solicitations

You Must:

You must document all income and expenditures from raffles or other events. Send copies of receipts and other documentation to APWU COPA, 1300 L St. NW, Washington, DC 20005.

You must record the name, address, union local number and the amount received from each COPA contributor. Send this information and all funds raised to APWU national headquarters.

You must promptly send in COPA contributions. Contributions over \$50 must be received by COPA within 10 days after they are made. Contributions of \$50 or less must be received by COPA within 30 days after they are made.

You must make clear that all donations are voluntary and that they will be used to support candidates for federal office. You must print the following message on the front of all COPA solicitation materials: "A copy of the COPA Committee report is filed with the Federal Election Commission and is available for purchase from the Federal Election Commission, Washington, DC."

You Can:

You can use local dues or treasury money as "seed money" to help raise COPA contributions provided that your costs do not exceed 33 cents for every dollar raised.

You can spend union dues money to print and distribute literature that educates your membership on the candidates' positions on the issues.

You can use dues money for non-partisan voter registration and "Get Out The Vote" drives aimed at APWU members and their families.

You can have APWU Auxiliary members and retirees as well as active APWU members conduct phone banks to raise contributions and/or pledges for COPA.

You Can Not:

You can Not raise money from, or sell tickets to, non-APWU members, non-retirees or non-Auxiliary.

You can Not mix COPA funds with local treasury or personal funds. A separate COPA account should be set up, and all COPA funds raised should be sent to national headquarters.

You can Not send the COPA money you raise directly to a candidate. All contributions must be made through the union's national COPA account.

You can Not accept free merchandise from a corporation to be used as prizes in a COPA campaign.

You can Not accept anonymous or unidentified cash contributions over \$50.



New Postal Reform Legislation Introduced in the Senate

03/23/2018 - On March 22, *The Postal Service Reform Act of 2018* (S. 2629) was introduced in the U.S. Senate. The APWU recognizes the efforts of the four bi-partisan Senators who worked to craft and co-sponsor the proposed legislation - Tom Carper (D-DE), Jerry Moran (R-KS), Heidi Heitkamp (D-ND) and Claire McCaskill (D-MO). "The APWU appreciates their efforts to achieve postal legislative reform that is fair to the APWU members, postal workers in general, the public Postal Service and postal customers," said Legislative & Political Director Judy Beard.

Much of the Senate bill is based on the foundation of H.R. 756, a bill introduced in the House of Representatives, which the APWU supports (while still

seeking some improvements). H.R. 756 is currently stalled in the House.

The new Senate bill also includes a number of elements from the *Improving Postal Operations, Service and Transparency Act*, introduced in the last Congress by Sen. Carper.

There are many positive elements in this proposed legislation that the APWU supports as a basis for further legislative action. This includes addressing the unfair and absurd pre-funding mandate for future retiree health care costs, imposed on the USPS by Congress in 2006.

The key to passing needed postal reform is strong bipartisan support. The APWU will continue to work with representatives of both political parties as we remain actively engaged to achieve quality postal reform.
