It's Tornado Time Spring not only ushers in tulips and outdoor trysts. It's also a time for tornadoes and severe thunderstorms. Families can be caught off guard if they ignore the pitches from local emergency officials to prepare for the unthinkable. Here's what you need to know -- talk to your children about what to do if a sever thunderstorm or tornado hits our neighborhood.



Watch vs. Warning-- A tornado watch means conditions are favorable for a tornado to form. A tornado Warning means a tornado has been seen locally

When the sirens sound-- A tornado warning is issued for any part of the county. A public safety officer, such as a police officer, reports a funnel cloud or tornado. A tornado watch is issued in combination with a severe thunderstorm warning.

When a tornado threatens ... go to your tornado shelter immediately. For best shelter, go to the lowest floor, preferably a basement or seek small interior spaces, which can form a protective core from flying objects and wind tunnel effects. Crouch as low as possible to the floor, facing down, and cover hour head with your hands. Get underneath a desk or anything heavy that can provide extra overhead protection.

Even if your children are young, it is not too early to start talking to them about emergency preparedness.
