Ed called the meeting to order at 4:00 pm.

John made a motion to appoint Bill Schroeter to Chairman of the Select Board.
Second by Ed. All in favor.

Rosemary handed forward an appointment document for Babetta Farley for Deputy Town Clerk. John made a motion to appoint Babetta Farley for Deputy Town Clerk.
Second by Ed. All in favor.

Holly stated that she sent out 72 lien notices. No deeds were done.

Holly handed in her contract for review.

Sgt. Batista gave a review of the police log from the past 12 weeks. Calls were down to about 33 per month.

Harold stated that he is having trouble turning around in Emerson Road and Page Road. It may be difficult to get emergency vehicles up there. The Board suggested inviting some of the residents on each road in to discuss the situation. Also to have Mr. Dombroski survey the town-owned piece of property at the end of Emerson Road to see if it would create a better turnaround.

Tracy discussed the Symquest computer/server monitoring contract with the Board which has expired. The Board will be meeting with Twin State Technologies on Monday, March 26th to see what kind of pricing they have to offer.

Ed made a motion to sign an Elderly and Disabled Tax Deferral Application. Second by John. All in favor.

Bill read a letter from the Unity Free Library requesting that Craig Shute be appointed to the Library Board in place of Marj Erickson, who resigned. John

suggested speaking to Craig first and also speaking with the newly elected Trustee Angela Buckley.

Tracy told the Selectmen that Deb Leahy asked for a copy of the February 26, 2018 Minutes and after she reviewed them she stated that they were incorrect and suggested some wording changes. Consensus of the Selectmen to leave the Minutes as written.

Todd Gregory stated that now that the Town voted for the new Brush Truck for the Fire Department, they have already called and ordered it. Expected delivery of the chassis will be July or August.

Todd and the Board discussed Emergency Management and the possibility of trying to get a generator hooked up this year between the Fire Department, Town Hall and Highway Garage. The contact at Emergency Management will be e-mailed to see if there are any grants available.

Chief Matthews discussed possibly billing for hazmat cleanup for emergency calls. He will write up something for the Board regarding the pricing to see if it would pay to start charging for these calls.

John made a motion to approve the Minutes of March 13, 2018 as written. Second by Ed. All in favor.

At 6:05 pm John made a motion to adjourn. Second by Ed. All in favor.
