About Shari Freidenrich



Shari Freidenrich is the elected Treasurer of Orange County and was re-elected in 2014 after running unopposed. As Orange County Treasurer, Shari is responsible for overseeing a \$9 Billion investment portfolio. She is also responsible for collecting over \$6 Billion of property taxes. Shari is a member of the nine-member Orange County Pension Board, which manages the \$13 Billion Orange County pension plan. Shari is one of the leaders in the field of municipal treasury professionals in the nation. Shari is the past President of the California Municipal Treasurer's Association and is a Past President for the Association of Public Treasurers of the United States and Canada. Shari is a licensed Certified Public Accountant (CPA) in California and holds several state and national certifications in public finance and funds

management. Prior to her service as County Treasurer, Shari had been elected as Treasurer of Huntington Beach four times and had served there since 1996. Prior to that she worked for 15 years in private industry as a Division Controller for McDonnell Douglas and as an Audit Manager for Deloitte and Touche specializing in the financial institutions, real estate and healthcare industries. She graduated summa cum laude from Washington State University with a Degree in Business Administration with an emphasis in Accounting. In her 21 years of service for Public Agencies, she has successfully and conservatively invested public funds. Shari has a proven track record of safety and has never lost a dime of public funds. Shari has been leader in a number of community organizations, including being the President for both the Huntington Beach Rotary Club and the Soroptimist Club of HB. She is also member of the Huntington Beach Chamber of Commerce and the South County Regional Chamber of Commerce. Finally, Shari is also the Past President of the Washington State University (WSU) Alumni Association and was elected to the Board of Directors for WSU Foundation where she is also serving as Chair of the Audit Committee. Shari received the WSU Alumni Achievement Award for her significant community and professional contributions to Washington State University.
