

Public Levee Access

Not all levees are publicly owned. Some levees are located on private property and RD784 personnel can only access private property because the State of California holds easement rights for levee maintenance and operations.

RD784 cannot give permission for anyone to trespass on private property of another. The following list of levees is provided for information on which levees are open to the **public for pedestrian access only.**
Unauthorized Motor Vehicles are prohibited on all levees except to cross as noted.

- 1. Western Pacific Interceptor Canal (Unit 4)** – All private property except North from Plumas Arboga Rd. to the first farm gate to the north (South Latigo Farms Gate) which is owned by Sacramento San Joaquin Drainage District (SSDD).
Legal Access – Access from Old Marysville Road at Plumas Arboga Road.
- 2. Bear River Levee (Unit 3A Urban) WPIC west to Highway 70**– Owner – Sacramento San Joaquin Drainage District (SSDD). Open to the public: No motorized vehicles.
Legal Access – Access from the Park and Ride parking lot at Hwy 70.
- 3. Bear River Levee (Unit 3A Urban and Unit 8) West of Hwy. 70 to the Feather River Levee-**
Owner - Three Rivers Levee Improvement Authority (TRLIA). Open to the public: No motorized vehicles.
Legal Access – Access at County Road 512 to landside toe parking lot at gate.
- 4. Feather River To Star Bend/ Unit 2B** – Owner – *Currently Privately Owned, but being purchased by TRLIA.*
Legal Access – Access to the waterside river bottom is by boat or from the waterside Bear River Setback. (See #3 above)
- 5. Feather River – Star Bend/Unit 9 To Linda Water District/Unit 2A** – Owner – TRLIA.
Legal Access – Access is open at Star Bend. Some of the river bottom is privately owned.
- 6. Linda Water District/Unit 2 To Hwy. 70/Unit 1** – Owner – SSDD and TRLIA.
Legal Access – **Pedestrian Access Only** is at Island Road and Garden Ave.
- 7. Riverside To Shad Pad/Unit 1** – Owner – SSDD and TRLIA.
Legal Access – Access is at the Shad Pad.
- 8. Shad Pad To Simpson Lane/Unit 1** – Owner – SSDD.
Legal Access – Access is at the Shad Pad and at Simpson Lane.
- 9. Simpson Lane To Dantoni Road/Unit 1** – Owner – SSDD and TRLIA.
Legal Access – Access is at Simpson Lane.
- 10. Dantoni Road/Unit 1 To Goldfields/Unit 7** – Owner – SSDD and TRLIA.
Legal Access – Access is *Pedestrian Only* at Dantoni Road.
All other Access Areas are Privately Owned.

11. Horseshoe Levees/ Rural Units 3, 5, and 6 – All Privately Owned. No Public Access.
