Mayor These opened the Public Hearings for discussion at 7:05 p.m. and explained the Public Hearing process.

# Bylaw 02-2022 - Traffic Bylaw:

Mayor These asked if any written submissions had been received regarding Bylaw 02-2022 — Traffic Bylaw.

CAO Yearwood confirmed that there had been no written submissions received at this time.

Mayor These asked anyone present to speak in favour of Bylaw 02-2022 – Traffic Bylaw.

Mr. Zetson was asking Council to provide the Playschool with a piece of land that they could allow children to play upon. This is requested because the playschool is hoping to also become a daycare centre at some time in the future. Councillor Berkholtz asked that Mr. Zetson put the request in writing and present the proposal to council at a regular meeting of council. Mr. Zetson agreed. In the meantime, administration will measure the area on Main Street (the UFA donated property to determine if this will satisfy Provincial requirements, currently they need 75 square meters.

Cory Zetson left the meeting at 7:20 p.m.

Mayor These continued the Public Hearing to discuss the 2022 Capital Budget.

#### **BUSINESS:**

2022 Property Assessments: Council extensively discussed the 2022 Property Assessments. Administration informed all present that the total assessment of the Village was raised by twelve million dollars (\$12,000,000.00). The Village property assessments had been audited from the year before and many properties had not been classified correctly. This has resulted in a drastic increase. The major impact will be felt by the homeowners in the new subdivision. Council spoke about different methods to work with the homeowners to pay this increase over time. The option of extending the time to pay bylaw from one month to two or three months. Also, council discussed allowing residents to pay the amount paid last year in the one-month period but allowing for any increase to be spread over 2 months interest free. Administration will draft something for Council to consider for the June meeting.

## Bylaw 02-2022 - Traffic Bylaw:

This Bylaw has come before Council multiple times in the last few months and the final revisions have been completed. First reading having been taken on March 21, 2022; Council chooses to move forward.

RES 098-2022: Moved by Deputy Mayor Heinz that Bylaw 02-2022 – Traffic Bylaw be given second reading.

CARRIED

RES 099-2022: Moved by Mayor These that Bylaw 02-2022 – Traffic Bylaw be given third and final reading.

**CARRIED** 

This Bylaw 02-2022 – Traffic Bylaw is now in effect.

<u>Bylaw 05-2022 – Tax Rate Bylaw</u>: The Tax Rate Bylaw was presented to Council and was put forward for first reading.

RES 100-2022: Moved by Deputy Mayor Heinz to give Bylaw 05-2022 – Tax Rate Bylaw first reading.
