## A. Resolution 18-905; Litter & Weeds Tax Liens

## **CITIZEN COMMENTS:**

#### A. Ms. Sharon DeVault

Ms. DeVault reminded everyone that she still has trees that are planted in her yard that need to be transplanted in the John & Mary Rudolph Nature Area. She also reported that the Indian Lake Historical Society only has approximately 27 pavers left for the harbor bridge area.

#### B. Mr. Ben Dapice

Mr. Dapice wished to thank Ms. Maxwell and Mr. Wallace for taking the time to speak with him regarding his drainage issue.

## **OLD BUSINESS:**

#### A. Marijuana Moratorium

The Village's current moratorium regarding medical marijuana is set to expire on October 15, 2018. In order to provide further information to council, Ms. Peggy Cline and Mr. Parker Lawrence, representatives from Extra Step Assurance, LLC was asked to attend the meeting. Extra Step Assurance is a company that provides education and compliance information regarding medical marijuana. They provided in depth information on the requirements for facility security, qualifying conditions for which medical marijuana can be prescribed, effects of CBD & THC and straining of marijuana to remove certain properties, reduction in the use of other opioids, and the various State departments charged with overseeing the cultivation, processing, and dispensing of the product.

# B. 205 Grand Handicap Parking

It was found that the new owner of 205 Grand is also handicapped and has provided all the necessary paperwork to the zoning department. The handicap parking sign will remain on the no parking side of Grand Ave.

## **NEW BUSINESS:**

#### A. Resignation of Jacob Brunson, Street/Water Laborer

Council was provided a draft of the proposed changes to the Ordinance regarding fences and walls for review. The draft was also sent to the solicitor for review.

Council was provided information received from the Ohio Municipal League to register for their annual conference.
