### **LPN teaching CNA**

- Florida Board of Nursing (BON) Administrative <u>Rule 64B9-15.005</u> entitled "Standards for Certified Nursing Assistant Training Programs" has been amended and became effective on 9/9/2015.
- This amendment introduced new language that states in subsection (3)(a) "A program instructor shall hold a clear, active Florida license to practice either practical nursing or professional nursing".
- The rule still requires that the program coordinator be a Florida Licensed Registered Nurse (RN).
- A memorandum went out to the districts and colleges on 11/17/2015 announcing this change.



- The LPN 7 G district teacher certification was added retroactively to 15-16 frameworks. You can find the certification details on the <u>CTE Teacher Certification</u> <u>Spreadsheet</u> under CTE Program Resources.
- LPN 7 G has also been added to "Any Health OCCUP G" to enable them to teach health science A & P, Health Science Foundations and any other courses that list "Any HEALTH OCCUP G" as its' teacher certification
- If you have a practical nurse already teaching under another certification, they will need to transition to the LPN 7 G to teach nursing assisting or any other courses under ANY HEALTH OCC G.
- Reminder: The old certification PRAC NURSE 7 G is not a practical nurse, but a registered nurse who teaches practical nursing. It is expired and cannot be issued any longer by a district.

## **CNA Rule Updates Cont.**

- In addition, the amendment of the rule 64B9-15.005 also introduced new language that states in subsection (6) "If a program has no test takers for one calendar year, the program shall be considered abandoned and program approval shall be rescinded."
- F.A.C. Rule: 64B9-15.006 Standardized Curriculum.
  - Amended to require that of the 40 hours of clinical instruction required in CNA training programs, The clinical instruction shall include at least 20 hours of long term care clinical instruction in a licensed nursing home or licensed long term care facility.



#### **Program Revisions**

- It's an ongoing process
- Over 100 programs from middle school to Associates degree
- Programs must be reviewed every 3 years (30 or so a year)

### 16-17 - Level 3 Designations

  - 8418210 270 Pharmacy Technician 1 through 7
  - 8427130 Electrocardiograph Technician 3



# Health Science Anatomy & Physiology = EQ

- Starting in 16-17, the course Health Science Anatomy & Physiology (8417100) will be designated as an equally rigorous (EQ) science credit.
- This designation will only apply to students taking this course starting in 16-17 and beyond and cannot be applied retroactively.
- This change has been made in all of the appropriate 16-17 curriculum frameworks and course code directory.



# **16-17 EMT Curriculum Frameworks**

- New programs were created in 16-17 for the new EMT length that was adopted.
  - All clock hour EMT programs will increase to 300 clock hours
  - All Credit hour EMT programs will increase to 12 credits
  - Health core competencies and courses are removed/integrated into EMT.



# **16-17 EMS Curriculum Framework Updates**

- The EMS A.S. degree and Paramedic programs will not be receiving an increase.
- Paramedic (PSAV) program will have a new program number in 16-17 due to the "Basic Healthcare Worker" being removed.
- Starting in 16-17, All of the current EMT programs will be placed on a dagger (teach out period) and new programs will be created reflecting the new length to replace the current programs. ( see table on next slide)

#### **16-17 Changes**

#### Orthotics & Prosthetics Technology (NEW) (1351230703)

- Length reduced from 77 to 60 credit hours.
- Starting in 16-17, all new cohorts of students should be enrolled in this new program. This program is replacing the program Orthotics & Prosthetics Technology A.S. (1351230702) which is being daggered starting in 16-17.

#### • <u>Surgical Services A.S. (135100002)</u>

- This program has been retitled from it's previous title of "Health Science "A.S.
- The previous title was not representative of the career focus of the program. As this program prepares students to work in various surgical health care fields, the new name reflects this.



#### 16-17 Changes

- <u>Cardiovascular Technology A.S. (1351090100)</u>
  - Change in the program name from Cardiovascular/Cardiopulmonary Technology to Cardiovascular Technology.
  - Deleted the secondary hours (88 credits) of this program
  - 77 credit hours is it's length
- Biotechnology Laboratory Technology AS (1341010100)
  - Biotechnology Specialist CCC (0626120101) previously a part of the Biotechnology AS under manufacturing has been moved under the Biotechnology Laboratory Technology AS.
- Biotechnology AS (1626120100) (Manufacturing Cluster)
  - Beginning in 2016-2017, new students should be enrolled in Biotechnology Laboratory Technology A.S. (1341010100). See details under new program section above.

# <u>Anesthesia Technology (AS - 1351999901)</u> New

- 71 credit hours
- This request was submitted by Eastern Florida State College to address the growing demand for properly trained Anesthesia Assistants in Florida.
- After successful completion of a Commission on Accreditation of Allied Health Education Programs (CAAHEP) or Accrediting Bureau of Health Education Schools (ABHES) accredited program, students are eligible to take the American Society of Anesthesia Technologist and Technicians (ASATT) qualification exam for anesthesia technicians.

### Proposed 17-18 Middle School

- Intended order is as follows:
  - 6<sup>th</sup> grade: Introduction to Health Science
  - 7<sup>th</sup> Grade: Orientation to Health Occupations
  - 8<sup>th</sup> Grade: Exploration to Health Occupations
- Curriculum frameworks updated to reflect the rigor and outcomes of the courses and to define the intended order of the middle school courses.
- Course Titles will be modified, but still under construction
- LPN 7 G added as a teacher certification for the Introduction to Nursing course



# **Proposed 17-18 - Dental Aid & Dental Assisting**

- Dental Laboratory Technician Teacher Certification (DEN LABTEC 7G) will be deleted from these curriculum frameworks.
  - This occupation does not have the experience or knowledge to adequately teach Dental Assisting students
  - No districts teaching these programs utilize this teacher certification to teach dental assistant.

# **Proposed 17-18 Practical Nursing -PSAV**

- New Course Structure will result in:
  - Creation of a new program number, CIP number and Course numbers
  - Dagger/teach out of current program for two years
  - For those two years, there will be two programs; an "Old" and a "New"
  - When current program has no enrollment, it will be deleted and the "NEW" program will take it's place indefinitely

- New Program will be created and the current will be daggered/ taught out.

## Proposed 17-18 Occupational Therapy Assisting

- Increase of length 74 credits
  - Currently 70 credits
- Additional time is needed to adequately teach additional content and skills that have been added to the occupation over the past 10 years
- New Program will be created and the current will be daggered/ taught out.

  - New Title- Exercise Science
  - Standards and Benchmarks updated
- The following programs have elected to eliminate the health core standards and/or Course from their FW:
  - Massage Therapy –PSAV
  - Optometric Assisting- PSAV
  - Practical Nursing -PSAV
  - Dental Hygiene- AS
  - Optician- AS
  - Ophthalmic Technician- AS
  - Respiratory Assisting- AS
- Dental Laboratory Assistant (8417150) Daggered in 17-18
